 BASE BEING POURED. THIS WILL BE PAID FOR OUT OF THE RESERVE
 ACCOUNT AND \$10,000.00 WAS MOVED TO THE RESERVE ACCOUNT AND
 DESIGNATED FOR THE TENNIS COURTS.
- 2006 RESERVE ANALYSIS TO BE FINALIZED. AS JANE WAS ABSENT, THE
