

**SEX OFFENDER INFORMATION FACT SHEET**  
**RISK LEVEL 3 NOTIFICATION**  
**Minneapolis Police Department**

The Minneapolis Police Department is releasing the following information pursuant to Minnesota Statutes 244.052, which authorizes law enforcement agencies to inform the public of a sex offender who has been released from custody regarding his criminal conviction. This disclosure is to inform you that the individual who appears on this notification has been convicted of a sex offense or other offense that requires registration with the local law enforcement agency that has jurisdiction over their residence. This offender has advised the Minneapolis Police Department that he is living in our community and is residing in the area of the **1600 Block Of Tyler Street Northeast, The Northeast Park Neighborhood.**

**THIS OFFENDER IS NOT WANTED BY THE POLICE AT THIS TIME.**

This notification is not intended to increase fear. It is our belief that an informed public is a safer public. The Minneapolis Police Department has no legal authority to direct where a released offender may or may not live. Unless court ordered restrictions exist, an offender may live wherever he chooses.

Sex offenders have always lived in our communities but it was not until passage of the **Community Notification Bill** and **Sex Offender Registration Act**, that law enforcement knew where they were living. Due to the passage of these laws, law enforcement can now share information with the public. Abuse of this information to threaten, intimidate, or harass registered sex offenders will not be tolerated and may be a crime. Such abuse could potentially end our ability to notify the community when sex offenders are released into the public.

**DESCRIPTION OF OFFENDER: African American Male, 5'11", 241 Lbs, Large Build, Brown Eyes, Black Hair ( Head Shaved), Medium Brown Complexion, And May Present With A Mustache.**

**DESCRIPTION OF OFFENSE:** This offenders victim pool are adult females who were strangers to him. His 3 prior sex offense convictions involved his using violence and the threat of weapons in order to gain compliance from his victims. He has demonstrated obsessive and compulsive behavior in the attacks. Prior Supervision violations include failing to follow his agents instructions(2006) and his use/possession of intoxicants.

**CONDITIONS OF RELEASE: INTENSE SUPERVISION**

**Must successfully complete sex offender and anger management programming.**

**May not possess sexually explicit materials in any form or venue, or patronize businesses where sexual entertainment is available.**

**May not operate a computer with internet access ,or use "900" phone sex lines.**

**Must spend 40 hours per week performing approved work (Is currently employed)**

**May not own, or operate a motor vehicle without prior approval.**

**Must submit to Ramdon drug/alcohol testing, polygraph, and GPS per agent.**
