# The Saga of the German Shepherds on the Greenway

About 10 residents of Merry Oaks and nearby Plaza-Midwood gathered early Monday, Jan. 21, to try to catch a tranquilized female German shepherd and find any puppies she had in the woods along the Briar Creek Greenway. An animal control representative also came out to offer assistance and advice.

The dog and one other grown shepherd, also thought to be female, have been hanging out in the greenway and in nearby woods. One Plaza Midwood resident has been feeding the dogs and slowly gaining their trust along the walkway between Masonic Drive and Logie Avenue. A third dog, a puppy about four months old, also has been seen hanging out with the older dogs.

Some residents of Merry Oaks had called Mecklenburg animal control about the dogs previously, and attempts to catch them had been unsuccessful. The dogs know the dense woods well and also use the small creek beds and ravines to move around.

Despite amazing efforts by several neighbors scrambling through dense woods, no dogs were caught. One was seen on the Merry Oaks side of the bridge, crossing into the woods immediately behind houses on Arnold Drive.

Rebecca Jones, a Plaza Midwood neighbor, now has a large kennel loaned by an animal control worker, and she plans to park the kennel near the path between Masonic and Logie. The plan is to continue

feeding the dogs near it and get the dogs used to the kennel, then catch them in the kennel.

She plans to register as a rescue group. Jones says animal control will work with the group to get the animals spayed and vaccinated, then return the dogs to the group to be fostered until a more larger or experienced rescue group can find them permanent homes.

In the mean time, the dogs remain in the woods around the greenway. Generally, they are shy and will retreat to the woods when confronted. If they approach, it's likely they're seeking food, because they've begun to associate people with food.

If you have a large fenced back yard and would be willing to help foster the dogs after they've been spayed and vaccinated, please let Rebecca know. Her number: 704.516.6882.

# Code enforcement along Central Avenue

The perception of our neighborhood is greatly affected by how Central Avenue looks. Automobile repair and/or sales from residential or "vacant" properties have become a particular problem recently.

This was nipped in the bud at a house across from the entrance to Merry Oaks Road recently when the owners quickly evicted tenants who continued to store and sell autos on the property after several warnings.

However the second duplex on Central near the Merry Oaks entrance (3507 central) is still a problem after more than a year. Numerous autos and "We Buy Junk Cars" trucks remain despite repeated citations from the City. Vehicles come and go constantly, illegally driving across the city planting strip (which many of you will recall we worked so hard to get installed years ago.) The landscaping is now just tire ruts in the mud. The entire front "yard" has been destroyed, jeopardizing the majestic old streetscape Oak trees which live there.

City Zoning Code enforcement officer for our area, Mark Fowler, has been issuing citations in the neighborhood interior as well as working on illegal signage, litter and general nuisances along Central and Eastway. Where cars are parked for sale on "vacant" private property, he has arranged with owners to immediately call for the cars to be towed. He has begun to aggressively cite littered properties along Eastway.

They will deal with it or forward to the correct officer. Both Mark and Alex intend to attend the MONA general meeting.

#### Briar Creek Bridge

Michael Davis of CDOT stated January 11 that the Central Avenue Bridge at Briar Creek has gone to City Council for contract approval and the contract includes several other bridges and does not specify when Central Avenue work will occur, however it is hoped that the Central Avenue Bridge will be first. Patsy Kinsey has requested that our bridge be a

priority. There will be a preconstruction meeting with the contractor and the inspectors. In general, the work is expected to be completed in June and includes new sidewalks and railings. Once it is complete the artist, Jim Gallucci, can install the railing art.

#### Commonwealth Park News

Charlotte City Council recently listened to about 60 residents of the Commonwealth Neighborhood and approved tough measures to restrict crime in Independence Boulevard hotels and motels. The new rules strengthen police authority to charge both property owners and motel clerks with misdemeanors if they permit crime at their establishment. Nancy Prescott of the Charlotte Inn said they would be happy to cooperate. Councilman Edwin Peacock has helped the Commonwealth Park Neighborhood Association with this effort.

The Commonwealth Park neighborhood is off Independence Boulevard and across Central Avenue from Merry Oaks, and has seen a surge of new homeowners, many who are remodeling their homes. CPNA continues to be very active, keeping an eye on future development near the Pinecrest/Commonwealth commercial areas and considering a possible park near the creek.

## Hillcrest Apartments

This was sent to Merry Oaks neighbors after Charlotte's first homicide of 2008 occurred at the Hillcrest Apartments on Arnold Drive:

Dear Merry Oaks Neighbors,

Our new year has unfortunately stepped off with the tragic event that unfolded in the early hours of new years Day morning. As a representative of the 48 families that reside at Hillcrest Apartments, I, as well as my staff on-site, am just as concerned about the criminal activity that has literally been brought to the front pages over the past months.

As an introduction, as the Regional Property Manager for Westminster Company, I represent the owners of Hillcrest Apartments as part of a nationally accredited property management organization. I oversee the management of seven properties in the Charlotte area. Westminster Company specializes in the management of affordable or subsidized housing. Due to the nature of our mission, security is a major priority for me and my staff. Every resident that enters into a lease with our property has passed a criminal and credit screening, as well as landlord references. We are serious about our stance against drugs and crime and use our contracts that we sign with our residents as our only form of enforcement. Let me emphasize that these steps apply to our leasesigning residents. The violent crimes that have occurred at Hillcrest Apartments in the past months have been at the hands of individuals who do not live in our community. They do, however, visit within the community and have ties to Hillcrest Apartments. It is these "visitors" that are the source of our pain and I have little to no means of screening these individuals or even identifying them.

Our most important ally in our war against crime is the police department. We have an excellent relationship with CMPD and its officers. We have always made proactive strides to improve our security to prevent crime instead of reacting to crime. We have openly expressed our need to ban any non-residents who commit crimes in or around our property. Recent legislation changes have made this process impractical and almost impossible. As the landlord, we must be present with CMPD and the

individual to be banned, in order to legally ban them from the property. As we all know, the activity that would lead to these bans almost always occurs outside of business hours when the manager is not on site. In the past, we could enter an agreement with CMPD authorizing any officer to execute a trespass order without our presence. As far as our residents at Hillcrest, everyone who has been arrested for criminal activity, or had direct involvement in such activity has been given a lease termination. However, enforcement of that termination ultimately is in the hands of our magistrates.

Making a long story short, many of our limitations in limiting crime within our community stem from decisions and legislation that are made by municipalities and organizations that like to look at the big picture without zooming in on reality. That reality is that our police force needs the freedom to identify and remove individuals who are known cancers to our community. I have asked representatives of Eastway Division CMPD for a list of apartment managers in the area so we can share information to prevent recycling any poor residents and their guests.

As law abiding citizens and residents, I enlist your help to pressure the powers that be to authorize the necessary power to enable CMPD and landlords to eliminate problems, and potential problems, from our community. Also, understand that we at Hillcrest Apartments have an important yet challenging role to provide affordable housing to families in need as an opportunity to better their lives and positively impact society.

## Voter Registration

#### Where can I get Voter Registration Forms?

Pick up a form at any Charlotte-Mecklenburg Public Library, any of the town halls, at the Board of Elections office (741 Kenilworth Ave., Ste 202) or on the BOE website at http://www.meckboe.org/pages/ Voter/RegistrationForm.html. Complete and sign the form and mail it to the address above. They will send a new voter card to you!

#### How do I change my address?

The Board must have one of two documents signed by the voter (an e-mail won't do.) Either send in your voter card with the change of address indicated on the back or complete a voter registration application form, showing your new address, and send it to BOE. Make sure you sign the card/form! They do the data entry and send a new voter card to you.

#### How do I change my party affiliation?

The Board must have one of two documents signed by the voter (an e-mail won't do.) Either send them your voter card with the change marked on the back or complete a voter registration application form, showing the new party affiliation, and send it in. Make sure you sign the card/form! BOE will send a new voter card to you



## People in the Neighborhood

One of the many talented and interesting people in Merry Oaks is Jason Hausman, who is a falconer. Raptors have been used for hunting for over four thousand years. One of the more famous, the Peregrine falcon, was almost exterminated from North America by DDT poisoning in 1950-70. Through the combined efforts of falconers and groups like The Peregrine

Fund, they were removed from the endangered species list in 1999.

Jason became interested in falconry after meeting a falconer when he was ten. Years later, he attended a workshop by the NC Falconer's Guild. Soon after he became a falconer. It is not easy, requiring large amounts of time, a written exam, a two-year apprenticeship, and both state and federal licenses just for starters. Becoming a master falconer requires seven years in the sport. The North American Falconers Association is the hub of American falconry and helps US Fish and Wildlife set regulations for the sport. There are very stringent laws pertaining to falconry with falconers subject to inspection at any time.

Different falconry birds have different characteristics, with some being very social, like the Harris' hawk, which sees the falconer as "part of the pack" while others can be more difficult to work with.

No falconer considers these birds to be pets; Jason says he has the scars to prove it.

General and Master class falconers can purchase captive bred birds or trap first year birds, while apprentices are required by law to trap first year birds from the wild. In most cases they do not take adults from the wild as they typically mate for life. Many falconers are also conservationists and often help to save birds that might not make it in the wild. Jason is active with the Carolina Raptor Center and often speaks to local schools and scouting troops about falconry and raptor conservation.

He mentioned that we have a number of raptors in our neighborhood. Coopers hawks, red tailed and red-shouldered hawks, barred owls, and even a great horned owl have been seen.

What's the attraction to the sport? Jason says it is like having "a front row seat to a National Geographic special. To see a falcon dive at 200 mph after a duck from 1000 ft. up, then hop up on your fist is quite an experience." But he also states, "Falconry is more than a hobby, it is a lifestyle."


