VII. New Business

- A. Approval of 2007 budget. **MOTION made by Bradley Fry to** *approve the 2007 budget with an assessment rate of \$78.00 a month effective January 1, 2007.* Seconded by Phil Trupiano. The motion carried unanimously.
- B. Rossmar & Graham renewal contract. Current rate is \$350.00 a month, the renewal would reflect the following increase \$361.00 a month for the first year; \$371.00 second year and \$382.00 for the third year. Clause to terminate in 30 days if there is a breach of contract, non-breach is 90 days. MOTION made by Phil Trupiano to approve Rossmar & Graham contract renewal as presented. Seconded by Bradley Fry. The motion carried unanimously.
- c. Management suggests replacing the locks of the pool entry gate and send residents new ASSA numbered keys. The homeowner would have to sign an agreement to obtain a key prior to distribution. A letter will be mailed by the Tuscany Shores board with detailed information and procedures. MOTION made by Bradley Fry to change the locks on the pools and make new ASSA numbered keys, one per household with an extra set to be charged to the homeowner for replacement and/or addition. This requires a \$50.00 refundable deposit. Custody of the second set of keys will be

maintained by Rossmar & Graham. Seconded by Michelle Andrews. The Motion carried unanimously.

- D. MOTION made by Bradley Fry to transfer \$15,000 into a short term CD. Greg Piwinski will give the board notification of the rate and maturity via e-mail. Seconded by Michelle Andrews. The motion was carried unanimously.
- E. MOTION made by Michelle Andrews to instruct Management to order post and "Tuscany Shores Homeowners Only" signs for the gazebo. Signs to quote Arizona State Statute. Seconded by Phil Trupiano. The Motion carried unanimously.

VIII. Old Business

- A. Lighting by the pool. Received one proposal for \$5,000. Close items due to lack of interest and excessive cost.
