

Report to the Board of Police Commissioners

"Building a Safer Detroit Through Community Partnerships"

The Detroit Police Department is committed to uphold its mission to provide a safe environment for our residents and businesses. We appreciate and value the role our citizens have played in helping us to take the guns and drugs off the streets of the city of Detroit.

SPECIAL ENFORCEMENT ACTIONS

Narcotics/Gang Enforcement

During the period of September 8, 2008 through September 14, 2008, Narcotics/Gang Enforcement executed 28 search warrants and 35 street enforcement actions within the boundaries of the city of Detroit resulting in the following arrests and confiscations:

- 38 Felony arrests
- 98 Misdemeanor arrests
- 5 Juveniles detained

Confiscated:

- 427.60 grams of cocaine, 47.5 grams of heroin, 1,489.50 grams of marijuana, and 169 pills, with a total street value of \$264, 188.00
- \$ 9,219.00 in U.S. Currency
- 19 Handguns

Homicide

Officers of the Western District responded to the 4000 block of West Warren on a "Shooting." Subsequent to the investigation conducted by members of Homicide, a subject was arrested and charged on September 9th with "1st Degree-Murder," "Felon in Possession," "Felony Firearm," and "Habitual Offender."

Police / Community Intervention

Northwestern District

On September 13th, officers of the Northwestern District arrested a subject wanted for a "Felonious Assault/Robbery" that occurred in the 9000 block of Heyden. The subject was charged with "Robbery Armed," "Assault with Intent to do Great Bodily Harm Less Than Murder," and "Habitual 4th."



Northeastern District

On September 10th, officers of the Northeastern District responded to the 7000 block of East Jefferson on a "Robbery Armed." Subsequent to their investigation, two subjects were arrested and both were charged with "Robbery Armed." Additionally, subject #1 was charged with "Carrying a Concealed Weapon," and subject # 2 was charged with Felon in Possession.



Southwestern District

On September 13th, officers of the Southwestern District were at an accident scene when they heard shots fired nearby and observed a vehicle traveling at a high rate of speed. The information was broadcasted over the air and the vehicle was subsequently stopped. Upon further investigation, recovered a weapon. Due to the officers' quick actions, four subjects were arrested and charged with "Assault with Intent to Murder."



Eastern District

On September 10th, while on patrol in the area of Gunston and Maiden, officers of the Eastern District conducted a stop of a vehicle for a traffic violation. As a result of their investigation, a subject was arrested and charged with "Violation of Controlled Substance Act" and "Fraud. Narcotics were seized.



Western District

On September 12th, while on patrol in the area of Wyoming and Kendall, officers of the Western District conducted a stop for a traffic violation. As a result of their investigation, a subject was arrested and charged with "Felon in Possession of a Firearm," "Carrying a Concealed Weapon," "Felony Firearm," and "Habitual 3rd." Two weapons were confiscated.
