I. Call to Order

II. Guests Speakers:

Gina Grieseman, Board member and resident of Lake Point. Ongoing conversation with the City of Peoria regarding Rio Vista Park and the Trail system. There is increased traffic, graffiti and non Desert Harbor residents camping and fishing on common grounds. She requested a barrier between the park, trail system and the Desert Harbor Community and has not heard back from Pearson or Mayor Barrett. Gina is circulating a petition for a wrought iron fence barrier and would like Tuscany Shores residents to be aware of the problem and perhaps sign the petition. To her knowledge, no impact study was done by the City.

<u>Peter Pingerelli.</u> Janice was kind enough to coordinate a garage sale for this Saturday, September 15 from 7 AM to 1 PM. There will be signs posted and an ad in the newspaper.

III. Open Forum – Homeowners (3 minute limit)

- Janet lives next to the pool and stated the light is continuously broken in the restroom. The board noted there is a self help committee that changes the bulb however Jim Caaney was ill. The board is looking for volunteers. *This will be taken care of.*
- Restrooms are not clean. Management informed the board that the restrooms cannot be locked; non-duplicate master keys were made so non-residents would not use the pool. The restrooms are cleaned monthly by the pool contractor. It is up to the residents to clean after themselves on a regular basis some residents' cleaningless are different than others.
- Landscapers trampoline over grass and leave ruts. Will notify the landscaper.
- Gary Albert recommends a handicap guard rail in the restroom so residents won't slip when the tile gets wet.
- Management to ask pool contractor to remove the fogginess of the pool water. Greg said this happens because the automatic shut off valve is turned off on a regular basis by unknown person.

Tuscany Shore has a large fountain that is overlooking its peninsula. In order to install the fountain, Desert Harbor has to tap into Tuscany Shores power. Tuscany Shores will receive the cost of electricity plus 10%.
