TRIAD

Is a concept of cooperation to reduce criminal victimization of the elderly.

TRIAD

Is a joint approach to crime and safety issues which affect older citizens and the enhanced delivery of law enforcement.

TRIAD includes the Louisville Metro Police Department, AARP, and the Jefferson County Sheriff's Office in cooperation with local seniors and service providers.

COMMUNICATE

by providing a forum for law enforcement and the community to share needs and concerns—and develop solutions.

EDUCATE

through crime prevention programs and victim / witness programs for older persons.

EMPHASIZE

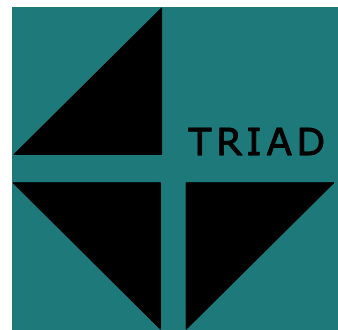
training programs for older persons to reduce fear and provide moral support.

INCREASE

public awareness of safety concerns for older persons and of the need to be alert for signs of elder maltreatment.

INVOLVE

seniors and law enforcement together in developing community-wide solutions.

attention to the crime-related needs and concerns of older persons.

involvement of the community in implementing effective solutions.

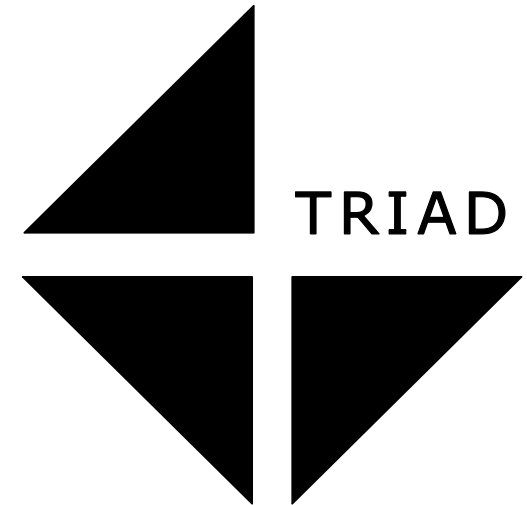
