ORDINANCE NO. 3 SERIES _____AN ORDINANCE PROPOSING TO ANNEX TO THE
CITY OF CROSSGATE A CERTAIN TRACT OF LAND

THE BOARD OF TRUSTEES OF THE CITY OF CROSSGATE DOES ORDAIN AS FOLLOWS:

Section 1. It is deemed desirable and is hereby proposed to annex to the City of Crossgate and extend the boundaries of the City to include same, that certain tract of land which is now within the County of Jefferson and which is adjacent to and contiguous with the present City boundary line described as follows:

Beginning at the point of intersection of the South line of Brownsboro Road and the East line of Crossgate, Section Number 2, P. & S.B. 20, Page 4 as recorded in the Office of the Clerk of the County Court of Jefferson County, Kentucky, said point being the Northeast corner of Lot Number 1 of the aforementioned Subdivision, thence with the Northeast line of Crossgate, South 33 degrees 33 minutes East, 703.41 feet to a point, said point being the Northeast corner of the City of Crossgate, thence with the North line of said City, and running through Lot Number 10 of the aforementioned Crossgate, Section Number 2, South 55 degrees, 36 minutes, 20 seconds West, 223.53 feet to a point in the West line of Crossgate Lane, said point being the Northeast corner of Lot Number 92 of said Crossgate, thence with the West line of Crossgate Lane, North 33 degrees, 28 minutes West, 604.56 feet to a point in the South line of Brownsboro Road, thence with the South line of Brownsboro Road, North 33 degrees, 32 minutes, 40 seconds East, 223.04 feet to the point of beginning.

Section 2. Immediately upon the effective date hereof, the Clerk of the City of Crossgate is hereby authorized and directed to publish this Ordinance one time in the Louisville Times and by posting copies of this Ordinance for at least ten days in four of the most public places in the City of Crossgate.

Section 3. This Ordinance takes effect upon its passage and approval.

AN ORDINANCE PROPOSING TO ANNEX TO THE
CITY OF CROSSEGATE A CERTAIN TRACT OF LAND

THE BOARD OF TRUSTEES OF THE CITY OF CROSSEGATE DOES ORDAIN AS FOLLOWS:

Section 1. It is deemed desirable and is hereby proposed to annex to the City of Crossegate and extend the boundaries of the City to include same, that certain tract of land which is now within the County of Jefferson and which is adjacent to and contiguous with the present City boundary line described as follows:

Beginning at the point of intersection of the South line of Brownsboro Road and the West line of Crossegate, Section Number 1, 7. & 8.B. 20, Page 3 as recorded in the Office of the Clerk of the County Court of Jefferson County, Kentucky, said point being the Northwest corner of Lot Number 93 of the aforementioned Sub-division, thence with the South line of Brownsboro Road, North 53 degrees, 32 minutes, 40 seconds East, 264.45 feet to a point in the East line of Harrington Way, thence with the East line of Harrington Way, South 34 degrees, 13 minutes East, 676.45 feet to the Northeast corner of Lot Number 46 of the aforementioned Sub-division, said point being in the North line of the City of Crossegate, thence with the North line of said City, crossing Harrington Way and running through Lots Number 46 and 47 of said Crossegate, South 55 degrees, 35 minutes, 20 seconds West, 252.22 feet to a point in the West line of said Crossegate, Section Number 1, thence with the West line of same, North 25 degrees 15 minutes West, 667.01 feet to the point of beginning.

Section 2. Immediately upon the effective date hereof, the Clerk of the City of Crossegate is hereby authorized and directed to publish this Ordinance one time in the Louisville Times and by posting copies of this Ordinance for at least ten days in four of the most public places in the City of Crossegate.

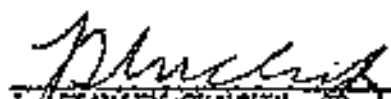

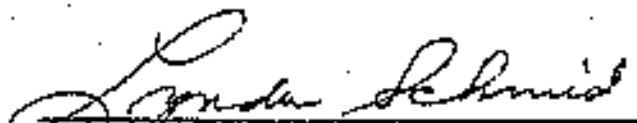

J U D G M E N T

This action having come on for a hearing on order of the Court, and it appearing to the Court that notices of same have been given in accordance with the Order of the Court, and it further appearing to the Court, and the Court being sufficiently advised on the Petition herein, that the property within the described boundaries of said city is sufficient to meet the said requirements of law which govern the creation of Sixth (6th) Class cities, and the Court being sufficiently advised,

IT IS ORDERED and ADJUDGED as follows:

1. That a city to be known as CROSSGATE, Kentucky, be and the same hereby is established as a municipal corporation of the Sixth (6th) Class city within the following described boundaries shown on the map filed with the Petition filed herein, to-wit:

Beginning at a point in the Northeast line of Crossgate, Section Number 2 as recorded in P. & S. B. 20, Page 4 in the Office of the Clerk of the County Court of Jefferson County, Kentucky, said point being South 33 degrees, 38 minutes East, 743.46 feet from the center line of Browneboro Road, thence with the Northeast line of Crossgate, Section Number 2 and continuing with Crossgate, Section Number 3, recorded in P. & S. B. 21, Page 44 in the afore mentioned Clerk's Office, South 33 degrees, 38 minutes, East, 1149.88 feet to the most Easterly corner of the above mentioned Crossgate, Section Number 3, thence with the Southeast line of said subdivision and the straight extension of same, South 52 degrees, 00 minutes, 40 seconds West, 938.91 feet to a point in the Southwest line of Crossgate, Section Number 1 as recorded in P. & S. B. 20, Page 3 in the above mentioned Clerk's Office, said point being South 33 degrees, 15 minutes East, 66.03 feet from the most Southerly corner of Lot Number 32 of the above mentioned Crossgate, Section Number 1, thence with the Southwest line of Crossgate, Section Number 1, North 35 degrees 15 minutes West, 1209.53 feet to a point, in the West line of Lot Number

within the boundaries of the City of Crossgate that certain tract of land in the County of Jefferson, State of Kentucky, adjacent to and contiguous with the boundary line of the City of Crossgate and which is more particularly described as follows:

Beginning at the point of intersection of the South line of Brownboro Road and the East line of Crossgate, Section Number 2, P. & S.B. 20, Page 4 as recorded in the Office of the Clerk of the County Court of Jefferson County, Kentucky, said point being the Northeast corner of Lot Number 1 of the aforementioned Subdivision, thence with the Northeast line of Crossgate, South 53 degrees 38 minutes East, 703.41 feet to a point, said point being the Northeast corner of the City of Crossgate, thence with the North line of said City, and running through Lot Number 10 of the aforementioned Crossgate, Section Number 2, South 55 degrees, 36 minutes, 20 seconds West, 223.58 feet to a point in the West line of Crossgate Lane, said point being the Northeast corner of Lot Number 92 of said Crossgate, thence with the West line of Crossgate Lane, North 33 degrees, 38 minutes West, 694.36 feet to a point in the South line of Brownboro Road, thence with the South line of Brownboro Road, North 53 degrees, 32 minutes, 40 seconds East, 323.84 feet to the point of beginning.

ORDINANCE NO. 6

SERIES 1969

AN ORDINANCE ANNEXING TO THE CITY OF CROSSGATE A CERTAIN TRACT OF LAND IN THE COUNTY OF JEFFERSON, ADJACENT TO THE PRESENT BOUNDARY LINE OF THE CITY OF CROSSGATE, MORE PARTICULARLY DESCRIBED HEREINAFTER

WHEREAS, by Ordinance No. 4, Series 1969, heretofore duly passed and approved by the Board of Trustees of the City of Crossgate, on February 17, 1969, the City of Crossgate proposed to annex to the City of Crossgate the tract of land hereinafter more particularly described; and

WHEREAS, it appears that there is no daily or weekly newspaper published in the City of Crossgate; and

WHEREAS, copies of said Ordinance No. 4, Series 1969, have been posted at least ten days in four of the most public places in the City of Crossgate; and

WHEREAS, more than thirty days have passed since the enactment and approval of said Ordinance No. 4, Series 1969, and no complaint has been filed in the Circuit Court of Jefferson County, or elsewhere, pursuant to the provisions of Section 81.110 or Section 81.240 of the Kentucky Revised Statutes, setting forth any reason why the said tract of land or any part thereof should not be annexed, and no other protest or remonstrance has been made against said Ordinance No. 4, Series 1969.

NOW, THEREFORE,

THE BOARD OF TRUSTEES OF THE CITY OF CROSSGATE DOES ORDAIN AS FOLLOWS:

SECTION 1. There is hereby annexed to the City of Crossgate and the boundary line of the City of Crossgate is hereby extended so as to include

the County of Jefferson, State of Kentucky, adjacent to and contiguous with the boundary line of the City of Crossgate and which is more particularly described as follows:

Beginning at the point of intersection of the South line of Brommboro Road and the West line of Crossgate, Section Number 1, P. & S.B. 20, Page 3 as recorded in the Office of the Clerk of the County Court of Jefferson County, Kentucky, said point being the Northwest corner of Lot Number 92 of the aforementioned subdivision, thence with the South line of Brommboro Road, North 33 degrees, 32 minutes, 40 seconds East, 264.45 feet to a point in the East line of Harrington Way, thence with the East line of Harrington Way, South 34 degrees, 13 minutes East, 676.45 feet to the Northwest corner of Lot Number 48 of the aforementioned subdivision, said point being in the North line of the City of Crossgate, thence with the North line of said City, crossing Harrington Way and running through Lots Number 46 and 47 of said Crossgate, South 55 degrees, 36 minutes, 20 seconds West, 252.22 feet to a point in the West line of said Crossgate, Section Number 1, thence with the West line of same, North 35 degrees 15 minutes West, 667.01 feet to the point of beginning.

SECTION 2. This Ordinance shall take effect upon its passage and approval.
