A change in management occurred with the departure of City Manager Mike Hein on April 7th. I want to thank Mike for his service and wish him well in his future endeavors. Already the City Council, staff and community seem to be rallying with a focus on the future.

Action on our most pressing priorities continues. Our management team - Interim Manager Mike Letcher and Assistant Managers Richard Miranda and Marie Nemerguth - plans to meet the 2010 budget timeline and present their initial recommended budget to Mayor and Council on April 21. The Rio Nuevo District Board will be securing professional management to provide appropriate private sector oversight to balance the City's fiduciary role. Nine internal candidates have applied for the Police Chief position, with the public process and final recommendations to be readied soon for Mayor and Council by Mr. Letcher and Mr. Miranda.

I believe wholeheartedly that the Mayor and Council will proceed with intensity to meet this City's challenges. We recognize residents' priorities for City services - public safety and crime prevention, street maintenance, parks and recreation. We have demonstrated our ability to move beyond disagreements through our shared commitment to serve the public and achieve our established goals.



Ok. So now that I have your attention, how can we make the topic of death and taxes more enjoyable? How about sharing how we helped put more money in people's pockets while they are still on this beautiful, green earth?

Getting cash to those hard working, tax paying families--you know, those that really deserve it!-- most certainly was the primary goal for the "The Credit You Deserve" campaign. This effort was an educational campaign that just wrapped up on Tax Day. The goal of this campaign was to use several strategies to inform residents of the Earned Income Tax Credit (EITC) and other immediate assistance available to working families during this current economic downturn.

## Census Bureau Canvassing by Hector Arellano

If you see someone outside your door with a handheld device and a messenger bag don't be alarmed, it is most likely a census person working on address canvassing.

The Census Bureau has sent out address canvassers as a part of early operations for the 2010 Census. This workforce is walking or driving through the streets of Ward III from April 6<sup>th</sup> through June 19<sup>th</sup>. They are checking that all addresses are in their database when the Census questionnaire is delivered in March 2010.

The purpose of address canvassing is to identify all housing units and other living quarters. Census workers will use hand held computers with maps on them to verify and list structures, including the collection of GPS coordinates for each location.

All Census workers wear an official identification badge and many address canvassers carry U.S. Census Bureau bags, making them easy to identify.
