# **CONA Meeting Report**

The most recent CONA meeting was devoted entirely to the Paris Whitehead shooting and very little was accomplished, due to varying opinions.

#### **Lake Project Update**

23 people participated in the most recent Crescent Lake clean-up project. The work day focused on the North end of the Lake, where invasive plants were removed and new plants, including beauty berries, wax myrtles and fire bushes were planted.

Additionally, the City Parks Department has agreed to take care of the Water Goats. Gary Crosby mentioned that people have said positive things about the observation area and that some have suggested shade trees for cover over the benches. Gary Crosby suggested the concept of "adopt a tree" and the board was positive. Crosby suggested planting Cassia trees and perhaps mentioning this idea at the General Meeting.

#### Crime

Rich Wall's truck was recently broken into. The perpetrators appeared to have popped the lock. A deterrent video camera behind the McGee house was destroyed recently. Kids were suspected, as there was gum struck to the wall.

#### **Banyan Tree Preservation**

Mike Flanagan has spearheaded a preservation effort of the Banyan Tree on the southeast side of the Lake. He has commitments from Foot lick, Vineyard and Olive with the City (all are arborists) to work on a plan to preserve the tree. The plan will be developed by Mike Phillips and some of the early ideas include fencing the tree, building up the soil around the tree and fertilization. Local companies have committed to donations and Mike Phillips should have a preliminary plan to present at the 05/18/09-General Meeting.
