#### BILLBOARD STUDY SESSION #2

#### At the City Planning Commission Meeting of May 21st, 2009

The Long Beach City Planning Commission will hold a study session on Thursday, May 21<sup>st</sup>, 2009, to review City staff's proposed changes to the municipal code regulating billboards and electronic message center signs.

The proposed changes include increasing restrictions on the size, location, and approval process for billboards, restricting size and brightness of electronic signs and billboards, prohibiting mobile billboards, and a number of other new standards and restrictions intended to modernize the City's zoning regulations that deal with these types of signs. The Department of Development Services hopes to create a strong, balanced, and fair set of rules to guide billboard and sign development in the City. The major goal of this proposed code change is to ensure that Long Beach will be prepared with the proper regulatory tools to manage the innovative sign developments found in today's market and anticipated in the near future.

The opinions of Long Beach residents and businesspeople are important as the Planning Commission studies this subject. Your views will help the Planning Commission determine a course of action for the City to set policies on billboards in the 21<sup>st</sup> century. We invite you to attend and express your thoughts.

Please Remember: A billboard (electronic or not) is for off-site advertising (i.e., a Coca-Cola sign); an electronic message center sign is for on-site advertising (i.e., sale prices at a car dealership).



The May 2nd Anaheim Street Tree planting where about 100 youth showed up to plant trees was a huge success. Trees were planted not only on Anaheim Street, but also at the end of Drake Park next to Cisco Burger that will eventually become a bike path. Mayor Foster, Councilmember Andrews and representatives from the 1st, 8th, and 9th district council offices also participated in the event. We appreciate the Wrigley Association members and all of our volunteers who helped supervise and keep the youth safe on this major corridor. WA members Lynette Ferenczy and Mike Laquatra were kind enough to lend their truck for the transport of bags upon bags of soil, mulch and woodchips. Tina Burnight and Matt Reno also hauled supplies in their truck. Also thanks to Brenda Martinez who provided translation services.

We would like to thank Long Beach Neighborhood Foundation (LBNF) for sponsoring WiGG in our endeavor to plant trees on Long Beach's major corridors. ## West Division Police Blotter

The Long Beach Police Department has noted an increase in the number of laundry room burglaries to residential complexes since January 2009, and would like to inform residents, specifically living or working in apartment buildings and condominiums with coin-operated washers and dryers, to be on alert.



Since January, there have been over 70 of these type of burglaries reported city-wide. However, a majority of them have occurred in the South Patrol Division, which is bordered by Anaheim Street on the North, the Los Angeles River on the west, Cherry Avenue on the East, and the shoreline on the south.

During these occurrences, the suspect(s) gained access to the laundry rooms, and in some cases, forced their way in. Once inside, the washers/dryers were pried open and the coins were taken. On a few occasions, possible suspects were seen leaving the area on bicycles. Other items in the rooms have also been taken, such as tools and miscellaneous electronics.

Apartment/condominium owners, property managers and residents are encouraged to practice the following safety tips, which could prevent their building from being targeted or victimized:

- If your laundry facility is equipped with a lock, use it when possible or invest in one.
- Install security cameras around your property and post signs indicating such
- Ensure you have adequate lighting in and around your property
- Pay attention to loud noise or commotion occurring in or around your laundry facility
- Remove the coins from your machines frequently
- Do not store any unnecessary items in laundry room

Talk with your tenants or neighbors and be sure they report any suspicious activity immediately by calling 9-1-1.

If you discover your facility has been burglarized or if you were a victim and didn't report the incident, please call the Long Beach Police Communications Center at (562) 435-6711. Anyone who may have any information regarding these crimes should contact Long Beach Police Burglary Detective Lorri Peck at (562) 570-7351.

On May 5, 2009, the Los Angeles District Attorney/Elder Abuse Section filed multiple felony charges against a self-proclaimed "gypsy" for kidnapping an elderly Long Beach resident for money, and Long Beach Police believe additional victims may exist.

On October 16, 2008, an 86-year-old Long Beach resident was standing in front of his house when he was contacted by a male subject driving a white, four-door sedan. The suspect lured the elderly victim into his car and drove him to two bank branches in Orange County. The suspect told the victim that his grandson had owed him money and exhibited a firearm. Fearing for his life, and the lives of his family, the victim withdrew several thousands of dollars from his account and gave it to the suspect. The victim later escaped, sought refuge at a restaurant in Orange County, and returned home in a taxicab.

The victim's family contacted the Long Beach Police Department and reported the incident. During the course of the investigation, Long Beach Forgery detectives learned that the suspect had stolen money from other elderly residents in Cypress, California and Las Vegas, Nevada. Coordinating with these agencies, Forgery detectives were able to identify the sus-

pect and compile their case to present to the Los Angeles County District Attorneys office who filed charges of kidnapping, robbery and financial elder abuse.

Investigators believe that there could be additional victims, and are asking any potential victims to come forward. In an effort to protect the integrity of the ongoing investigation, detectives are not releasing the suspect's identity or photo, but believe he is a member of a transient criminal organization commonly known as "travelers" or "gypsies". He is described as a 49-year-old heavy-set male, with short brown hair and brown eyes, a "goatee" beard and a medium complexion. The suspect has utilized several different aliases and birthdates and currently has felony warrants for his arrest out of Washington, Oregon and Nevada. The suspect was arrested in Las Vegas on April 8, 2009, and is currently awaiting extradition.

I am writing to you all in the midst of Flag Day festivities here in American Samoa. What is Flag Day you ask? Well it is a local holiday (officially April 17) which marks the anniversary of American Samoa becoming a U.S. Territory. It is the biggest annual event on American Samoa's calendar. It was on this date in 1900 that the U.S. Navy raised the American Flag here and American Samoa as a U.S. Territory was born.

American Samoa is the only unincorporated and unorganized territory of the United States. This unique relationship with the United States ensures that land continues to be communally held by aiga (families). Today around 90% of land is communally owned. American Samoa is also the only U.S. territory south of the equator. Flag Day celebrations will take place all weekend and include traditional dancing (siva) and singing (pese), colorful parades and Fautasi - longboat - racing. This morning before work I was able to step outside of the office to catch one of the Fautasi races as the boats whizzed by. Quite a sight to see.


