





Changes to the Constitution

Proposed Changes to the BCCA Constitution, April 28th, 2009 [] Yes [] No

1. Change the name of the organization from Broyhill Crest Citizens Association to Broyhill Crest Community Association.

Rationale: The primary purpose of the Association should be to promote the growth of community within our neighborhood.

2. Allow the Executive Council to set the membership dues for the Association.

Rationale: Dues have not been changed in the last 30 years and the executive committee needs flexibility to ensure that there is adequate income to cover the association's expenses.

3. Eliminate the position of Second Vice President and make First Vice President simply Vice President.

Rationale: The job of the Second Vice President is to run the Youth Committee, which has not existed for years. Reduce the number of officers to recruit.
