Board of Directors Board Meeting August 7, 2008 – 7:30 -9:00 p.m. Peterson Dumesnil House

The regular monthly meeting of the Crescent Hill Community Council was called to order on Thursday, August 7, 2008, at 7:30 p.m. by President Pat Brinson, at the Peterson-Dumesnil House.

Motion by Anne Adams: to develop an "Annual Plan of Activities and Finances" that will reflect an overview of proposed activities for the upcoming year, including the associated anticipated income and expenses with monthly reporting of changes and modifications to the projected "Plan".

Motion by Brian Butler for CHCC to pay annually for the five executive officers and parliamentarian to attend The Parliamentary Training Workshop. If an officer cannot attend, that paid spot may be filled by another board member whose way has not previously been paid by CHCC. Motion by Barb Bower to give N. Hite \$50.00 for block party that was held July 19---as sent in email prior to July 19.

Motion approved.
