Amnesty of Past-Due Fees to Rejoin Brookwood Recreational Association

The following 1-day only policy was approved at the April 8, 2010 board of directors meeting.

"If you have not been a member for the past three years (since May 2007) the past due penalties and initiation fee will be waived on the amnesty registration date, provided the full year dues of \$300 for the coming year are paid in advance. The amnesty date is tentatively set for May 29, 2010, the pool opening date / new member registration party."
