Official Rules

The Sunnyhills Neighborhood Association (SNA) is a non-profit group of local volunteers who are actively working to improve our neighborhood, and thus the City of Milpitas, through positive activities and programs. SNA defines the Sunnyhills neighborhood as the area bordered by Fremont City (north), Milpitas Blvd (east), 680 (west), and Jacklin Rd (south).

The purpose of this contest is to encourage and promote community participation within Milpitas—by Milpitas residents, to get our young people involved and active within our community, and to potentially secure a new logo for SNA that will be used on their newsletter, a variety of printed material (stationary, business cards, etc.), website, advertisements, etc.

Contest Period: From October 15, 2010 through November 27, 2010. SNA will promote this contest in their October 2010 Newsletter, through the local high schools, and through the Milpitas Post.

Eligibility: In order to submit an entry you must be a resident of Milpitas. Entrant does not need to be a member of SNA or live within the Sunnyhills area to submit an entry. If entrant is younger than 18 years of age, then entry must be approved by a parent and/or legal guardian. Any individual who is on the current SNA board or is an immediate family member and/or household members of such individuals, are not eligible to enter.

"Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses. "Household members" shall mean people who share the same residence at least three months in one calendar year. Void where prohibited. Some restrictions apply. One qualifying entry per person. You need not be present to win.

How to enter: Email your entry to locule63152@mypacks.net by 11/27/10 by 3pm. Entries received after this date and time will be disqualified. Title the subject of your email: SNA Logo Contest. All emails must include the following information: full name, address, phone number, age, and email address. If entrant is under the age of 18, then please also include the above information for the parent and/or legal guardian of the entrant.

All entries become the property of SNA and will not be returned and may be used by SNA for any purpose and in any media in perpetuity. All entries must meet the requirements below in order to qualify for participation. Entries that are missing information or do not meet the entry or eligibility requirements will be disqualified.

By entering into this contest entrant hereby transfers and assigns all intellectual property rights (including, but not limited to, copyright and trademark) to SNA. By entering entrants agree to abide by these rules and grants SNA the right to edit, publish, display, promote, broadcast, and otherwise use their entries without further permission, notice, or compensation, in any media now known, or hereafter developed.

By entering, each contestant agrees to be bound by the rules. SNA is not responsible for illegible, lost, delayed, misdirected mail/email, errors in faxes or shipments, busy phone signals, or incomplete entries.

Entry Requirements:

- Logo must be clear and recognizable at a small size and must be scalable, to include use on posters and signs.
- Entry must be the original, unpublished work, and sole and exclusive property of the entrant.
- Should portray SNA in a positive light.
- No copyright infringement.

- Entry must not contain any content, material, or element that displays any third party advertising, slogan, log, trademark, or otherwise indicates a sponsorship or endorsement by a third party, commercial entity, or that is not within the spirit of the contest, as determined by SNA, in its sole discretion.
- Entry should be in JPEG, TIFF, or GIF format.
- Be less than 5mb in size (limitation of email server).
- Shall be free of infection, including computer viruses & bugs.

Judging:

- SNA reserves the right to disqualify any entry or entrant if he/she/it does not meet the contest requirements.
- The SNA board will choose the winning design. Their decision on the winner will be final and no further correspondence shall be entered into.
- SNA has the right not to select a winner, if in its sole discretion, no suitable entries are received.
- Winners will be announced at SNA's annual International Potluck, scheduled for Wednesday, December 1, 2010. The public is invited to attend and participate in this event.

Prizes:

Prize will not be released until SNA receives all required documents; documents must be returned within five (5) business days of receiving the Form. Failure of prize winners to return the Form within the required timeframe will result in automatic forfeiture of any prizes and all such prizes shall be awarded to an alternate winner.

Unforeseen Events: SNA reserves the right to change this contest at its sole discretion at any time that SNA becomes aware of any circumstances or occurrence which would materially affect the contest security or fairness. SNA reserves the right to announce any contest rules changes over the air, in print or posters, or by via electronic medium. SNA is not responsible for the inability of the winner to accept the prize for any reason.
