Elder Care – Robin McMullen

Robin McMullen of Riverside County Adult Services and the I CARE Elder Abuse Program gave a timely and very informative presentation, primarily on the issue of Elder Care, with additional information on Fraud and Identity Theft. For concerns about a neighbor you suspect may need care, there is an Elder Care Hotline 1-800-491-7123. Robin also reminded us that we are entitled to a free copy of our credit report each year from each of the three reporting agencies, and she encouraged us to request these one at a time throughout the year. City Updates - Mike Gardner

Mike followed up on the **fraud** issue by giving us contact information for Brian Money at the City's Fraud Prevention unit (951) 826-5311 or 787-7911, bmoney@riversideca.gov

Beware of **false address painting scheme**. There is no company that has an agreement with the City to paint addresses, so don't pay them.

Construction items - The Mission Inn Annex is being considered for rehabilitation. The Convention Center is due for upgrades which would close 5th Street between Market and Orange. The Municipal Auditorium will be getting a new roof and seismic re-fitting. It will close in August and will be closed for approximately 24 months. The Museum will also be re-roofed. The new Museum and Library are in the design stage. The City plans to renew/extend Measure C to fund maintenance of the library.

Ward Elections - Next year will bring elections for the odd numbered wards. Mr. Gardner will run for re-election, and there are two residents of the Wood Streets area who have submitted their names to be candidates.

The City will soon enact a new **animal control ordinance** to limit the number of licensed dogs to four per household.

Mr. Gardner told us to report all instances of **illegal fireworks** in the neighborhood to 787-7911 and to remind him next year about trouble spots in the area so he can get the fireworks enforcement Patrol to come by next year.

Preferred Parking Program will be modified for the two sections of Ramona Dr. The change will assign different color codes, and new parking permits and passes will be mailed to residents of the two sections. [New signs have not been posted yet, but new passes were mailed to the residents of Ramona and went into effect on September 6.]

Historic District Research Interview Cindy Jensen

Denise Lawrence is a Ph.D. Professor, Department of Architecture, Graduate Coordinator, Master of Science in Regenerative Studies College of Environmental Design Cal Poly Pomona. She is writing a book about five cities in Southern California that have historical significance because of their architecture. The city of Riverside is one of them. She met with me and Judy Mahoney, and by phone interview at a later date with David Vangsness.

Denise was very interested in how we as a neighborhood designated by our city as Historic restores, cares for and keeps up the values as the official caretakers of our homes.

What was of real interest to me, however, was to learn that neighborhoods in other cities actually have individual residents assigned as block captains to a particular street for the sole purpose of reporting homes that didn't conform to what was expected. We seemed to stand out by contrast in that we are really people-driven, not rules driven. Our concern is for the welfare of our neighbors.

As I began to reel at these concepts, I thought of all the things I was thankful for. I was grateful we don't have block captains patrolling our streets to write up infractions. I was glad we have a city with tools and resources in place for our use. I was pleased we have a Mayor, City Hall, Code Compliance, City Councilmen, Office of Neighborhoods, Riverside Neighborhood Partnership, Public Parking Services, Police Department, Fire Department and all the countless departments, services and staff that are there to help us. I was happy for the effort and investment we've made into making ourselves known to the city and RCC. It has paid off.

We are blessed with the many City services available to us and that the City is active in helping us as individuals and as a neighborhood. Our city isn't perfect, and neither is our neighborhood because human beings are involved, but when we approach issues in a calm respectful manner and let others know that we are willing to be part of the solution, we make far better strides in getting problems resolved. I was proud to share with Denise that people who move into our neighborhood come with the desire to live in a Historic District. They don't seem motivated to turn their homes into futuristic buildings of steel. They are already self-motivated to take part in preserving their homes and neighborhood. We take pride in where we live and are eager to help each other.

Denise promised us a copy of her book when it comes out, and wrote to us this nice note after the interview: "I enjoyed getting to know you and your approach to community organizing. I am impressed with your achievements and hope your neighbors recognize them, too. Good luck with all your endeavors!" —Denise Lawrence.

CARE — Curtailing Abuse Relating to the Elderly

The July 10 presentation by Robin McMullen of Riverside County Adult Protective Services-CARE Program was very informative and timely. The Adult Protective Services (APS) program is set up to provide assistance for elderly or disabled people who are in need of some kind of assistance. Robin outlined what we can do if we see an elderly person in decline and want to help; someone who could become a victim either of their own frailty or of a scam artist. The department is very careful not to violate a person's privacy - either yours or the subject's. Personal autonomy is also protected. Robin recommended if we are concerned not to hesitate to contact APS. Rather than be "nice," be "nosy and concerned" instead, as it may save someone's health or bank account.

Also, the County has in-home supportive services for low-income residents that need help. If they have a problem with plumbing or electricity, the City has low cost loans. Often, APS seeks to locate family members and conduct mini-exams and interviews to determine the person's abilities and needs.

The goal of social services is to bring resources to bear upon situations to enhance the elder's quality of life while continuing to safely live in their own home.

CARE is a subunit of APS that manages the County's three elder abuse multi disciplinary teams. The teams include many agencies such as animal control, code enforcement, police, fire, etc., to more efficiently resolve elder issues. A Secret Space on Larchwood

History Corner – by Ann Frenkel

Wood Streets houses are always full of surprises, and the Spanish Mediterranean cottage at 3657 Larchwood Place, built in 1931 by builder Harry R. Low for \$4,000, is no exception. The Depression caused several initial years of unstable tenancy; however, in 1938 Tolbert M. and Marian Perrin, owners of Perrin's Jewelers on Main St., moved in. The next long-term owners were Palmer C. and Fern Risley who spent almost 30 years in the house. Palmer was an accountant for the IRS, and Fern was a school teacher. The Risleys undertook several upgrades, including excavating the basement and adding a half bathroom, but not touching the striking green, white and mauve deco tile in the main bathroom. Palmer left a fascinating find tucked away in the attic, a ledger book marked "Old personal records of no value to anyone else," in which he records every single expense from 1914 to 1924 ("piece of pie, .05"). Lynne Seymour purchased the home in 1985 and has really developed the Mediterranean feel, landscaping the front and back with drought tolerant plants (with Nan Simonsen's Nanscapes), fountain, pond, fire pit, and colorful ceramic tile. Lynne also added a studio space to her garage. French doors originally from a California Baptist University building flank the studio back giving a lovely airy feel.

Robin McMullen also reminded us that every person is entitled to receive a copy of their own credit report once a year from each of the three credit reporting agencies. It is recommended you request one three times a year by making the request from these spaced throughout the year.

Hello Judy and Members of the HWSA,

Recently I was contacted while at work by my brother-in-law while he was doing work at our home. He called to tell me a co-worker of his had left a door open at our house and our Golden Retriever "Edward" had gotten loose. My brother-in-law had driven around the neighborhood for nearly an hour before contacting my wife or me. As I was on the phone with him I received an e-mail from Judy about an upcoming HWSA event. When I saw the e-mail I responded to it, informing her about our dog getting out. I gave her a description, his name and left a phone number where she could reach me with any additional questions.

The minute I sent the e-mail to Judy, I began gathering my things to head home to help with the search. I also began

thinking about what I was going to tell my 7-months pregnant wife who loves Edward but hates cleaning up after him. Before I even had a chance to call my wife or get into my car I received a call from Judy, telling me that Edward had been found. Judy had received a call about Edward and was preparing to send out an e-mail asking for information when she saw what I had sent her. She gave me the name and phone number of the neighbor (Lindy) who had found him. I called her and arranged to pick him up. When I arrived I was told that while on a walk she had come across him at the corner of Beechwood and Riverside; he looked confused and tired. Her first thought was to call Judy so an e-mail could be sent out in hopes of finding his owner, and we all know what happened after that.

We just wanted to take a moment to share this story. All too often we hear there is not a sense of community left in the world. How neighbors don't know each other or care about what goes on their neighborhood – but that is not true here in the Wood Streets. Judy and the other members of HWSA have worked hard to maintain a sense of community and caring in our neighborhood, and we feel blessed to live in such a wonderful area. Thank you to Judy, Lindy and Lindsey for facilitating Edward's safe return and taking care of him. Most importantly thank you for showing us how special it is to live in this neighborhood.

Security System Alert

This month we received quite a few emails from residents concerned about home security system representatives.

One resident wrote that a man approached their home on Beechwood and talked about the change from Brinks to ADT. Apparently he makes his pitch to whatever security sign is at a home. Police non-emergency told her to call 826-5314 to report the incident. The woman was very impressed that we have an e-mailing available for such things. Police non-emergency is 787-7911. If you feel at all threatened, call 911.

Cindy Jensen added – It would be my council to call the security systems themselves and inquire what the protocol would be for their salesmen in contacting potential customers. It still sounds to me like this could be a sales pressure technique to gain entry. If we are going to err, let us err on the side of caution. My husband and I have Protection One. Our last bill included a "security alert." The brochure told customers what to be aware of. (See page 6.) Title / Grant Deed Scam

Nancy Castillo alerted us about a Title Compliance scam. In response to our email inquiry, the County Assessor's office responded with the following:

As you are aware, recently there has been a mass mailing of notices to Riverside County residents from a private, non-governmental company called TITLE COMPLIANCE OFFICE (Records Retrieval Division). These notices appear to be official county mail recommending that all property owners should have an official or certified copy of their grant deed. They are offering the service of providing the grant deed for a fee of \$167. In an effort to inform the public regarding this matter, several press releases have been issued and our website has been updated.

The Riverside County Assessor-County Clerk-Recorder does not endorse this company. You may purchase a copy of your official grant deed in person from one of our offices, online or via mail request for substantially less (approximately \$10 depending on the number of pages).

In person - the cost of an official record is \$7 for the first page, \$1 for each additional page, and an additional \$1 for certification of the document.

Online - Go to www.riversideacr.com select "Online Services", "Records Index Search". The cost is the same as above however, VitalChek charges an additional \$5.00 fee for the online service when purchasing with a credit card.

Mail - Mail requests to: Assessor County Clerk-Recorder – P.O. Box 751 – Riverside CA 92502-751 Attn: Certified Section. Mail processing time is 2 - 4 weeks.

His name is Glenn Furukawa. Perhaps you have seen him; he's tall, slender, and walks his large, white poodle "Cooper" through our streets every morning and evening. Glenn is a retired Police Officer from Honolulu and he is watching over us all.

He always carries his cell phone and while on his walks he is keeping an eye open for potential problems or trouble. Over his years here Glenn has reported many incidents to the police department including traffic accidents, thefts from yards and garages, graffiti, suspicious vehicles and people being in places he knew that they didn't belong.

If you have seen Glenn, I'm pretty sure you have spoken with him as well, because he is so very friendly. Glenn always has a smile and open greeting for everyone. He loves that our neighbors are so friendly and enjoys the friendships that have begun with his walks.

Glenn was a corporal in the Marine Corps and served two tours of Viet Nam, first in Da Nang and then in Chulai. In his 32 year career as a Honolulu County Police Officer he served as a patrol officer, a combined 20 years in the Narcotics Division and 11 years in Intelligence fighting organized crime. He was awarded many citizen citations for excellence in service and intradepartmental awards as Officer of the Quarter. After he retired from H.P.D. he worked four years as the Chief of Security for a large Development Company in Hawaii.

The City of Riverside has raised the reward for helping catch a graffiti vandal to \$1000. Riverside is a leader when it comes to graffiti awareness, education and eradication.

Over the last few years, the average time for a reported case of graffiti to be removed has been greatly reduced and is now well under 24 hours. The community outreach is tremendous and the volunteer "paint out" events are inspiring, with so many people, particularly our youth, giving their time and energy.

Removing graffiti from the City is truly a community effort, and with the help of you and your neighbors, we can continue to improve our City's results, showing those who perpetuate graffiti that Riverside won't stand for it.

Here are a few ways you can help in this effort:

- 1) Call 311 to report any graffiti visible from the street. For more information on how 311 works and how the service can help, see http://crmweb.riversideca.gov/
- 2) Put together a group to complete a "paint out" or "green wall" (vines, etc.) planting at a neighborhood park or other space visible to the public.

3) Schedule an assembly to educate a group of young people at a school, church, after-school program, community center, etc.

- Ask for proper ID and confirm the rep's standing with company
- Call your Security company to report any deceptive sales tactics
