# MCC HOA Covenants Revision Will Take Place In 2011

The Millcreek Crossing Covenants will be revised in 2011 as required by law. Remember that all residents are governed by the HOA covenants whither they are members or not. (Real estate agents are required to provide covenants during your closing). To be part of the revision process you need to be a current member of the HOA.

Membership in the HOA is a responsibility of residency and a strong HOA gives us a united voice. This was demonstrated during the tornado several years ago when the county responded very promptly to the HOA's request for support. The same holds true

when we request utility servicing.

Historically, a percentage of home owners carry the load for the entire sub-division while some residents ride along for free. The efforts of the members ensure that property values and community appearance is maintained for the entire neighborhood. Active members also pay utility bills (electricity and water) and for the care and maintenance of the entrance which is very important to our visitors' first impression. Membership is only \$50.00 per year; this is cheap (.96 cents a week) due to the volunteer efforts of a number of your neighbors and the board.
