#### BERWICK BLOCKWATCH IMPLEMENTATION: CANVASSING THE NEIGHBORHOOD TO BEGIN MAY 2, 2009

Lloyd Clark, BCA Blockwatch Chairman, and Deborah Points, Vice-Chairman, conducted a Training Session for Blockwatch Volunteers at our meeting on March 3, 2009 which was held at the Redeemer Lutheran Church. This was the third meeting in a series designed to inform the community of the purpose, responsibilities/roles of its members, organizational structure, goals, plan/strategies, recruit volunteers, training, and to solicit ideas/ suggestions for implementation of the BCA Blockwatch Plan. Blockwatch Training materials were passed out as well as Blockwatch Signs for members. Based on the community input, it was decided that we work from the "bottom up" since Berwick encompasses an area

comprised of 1600 residents and recruit additional Zone Captains for our three Zones (A, B, & C). We will break down Berwick into much smaller areas where folks can get to know residents as we plan to sponsor various activities, i.e. Cookouts, bicycling, walking, etc. The plan is to contact our Blockwatch volunteers to canvass the neighborhoods and inform residents of our Blockwatch program, distribute information regarding Blockwatch activities and important contacts within our organization such as the Precinct Liaison Officer, Jarrod James. We also can determine by your street address what zone you reside in and who eventually will be assigned to be the contact person/Zone Captain.

We will be calling residents who signed up as volunteers to participate in our "Canvassing the Neighborhood" campaign on May 2, 2009. Details of this event will be forthcoming.

The downsizing of our economy has

increased the importance of Neighborhood Block watches due to the increase in crime and police budget cuts. This is why it is so important to become the "eyes and ears" of the neighborhood and join your neighborhood Blockwatch. It's as easy as calling 614.Berwick (237.9425). I am pleased to see the interest and enthusiasm from our members and I welcome your suggestions.

# Berwick Power Outages

Lloyd Clark brought up the issue of power outages based on community input he has received at the March 3, 2009 BCA meeting. In a recent Dispatch Article, the Berwick Community ranked #8 out of 15 in terms of the worst power outages in Franklin County. As a result, Mr. Clark sent a letter to Mary Flint, AEP Community Affairs and Faith Pointer requesting factual information for selected areas pertaining to the causes, frequency, duration, current policies and procedures to resolve power outages, and if there are any plans to upgrade the electric system. In many cases, residents have remained without power for several days. This has an adverse effect on the health, welfare and quality of life in particular for our most senior residents.

Mr. Clark also extended an invitation for an AEP Representative to speak at the next BCA Civic Association meeting to be held **April 7, 2009** at the Lower level of the Redeemer Lutheran Church.

I would encourage residents to also send complaints regarding electric issues to: Office of the Ohio Consumers' Counsel.

The Office of the Ohio Consumers' Counsel (OCC), the residential utility consumer advocate, represents the interests of 4.5 million households in proceedings before state and federal regulators and in the courts. The state agency also educates consumers about electric, natural gas, telephone and water issues and resolves complaints from individuals. #### Gelsilica's Key Lime Pie

- 6oz. can frozen limeade concentrate, thawed
- 14oz. can sweeten condensed milk
- 9oz. container frozen whipped topping, thawed
- 9 inch graham cracker pie crust

Combine limeade, condensed milk and whipped topping in a large mixing bowl; mix well.

Pour into pie crust; freeze until firm, about 3 to 4 hours. Serves 8

## Gelsilica's Lemon Chicken

- 6 boneless, skinless chicken breast
- 1/3 cup lemon juice
- 1/4 cup butter, melted
- 1 teaspoon garlic powder
- 1 teaspoon poultry seasoning

Place chicken in a greased 13"x9" baking pan; set aside.

Combine remaining ingredients; pour over chicken.

Bake at 350 degrees for one hour.



## Neighborhood Beautification

Spring and warm weather are here and hopefully to stay! The neighborhood beautification committee has a few reminders for the Berwick Community:

#### Yard Waste Removal

Last January, in order to reduce expenses to address a budget shortfall, the City of Columbus canceled its contract with Rumpke for yard waste removal. Previously to January, Rumpke was the service that would collect yard waste placed at the curb every Tuesday in Berwick.

Please do not place leaf bags or yard waste containers on the curb for collection unless you have paid for the service.

The city is still exploring options to reintroduce this program, but in the mean time the following options are available to recycle yard waste by dropping it off at select locations.

- 1. Com-Til, the City's compost facility (no grass clippings), 7000 Jackson Pike, Columbus (614 645-3152).
- 2. Kurtz Bros. and Mulch Manufacturing Inc. accept leaves, grass clippings, small branches and holiday trees at the locations listed below. Yard-Waste should include only organic materials from your own yard. They will not accept waste in plastic bags. You may be asked to show proof that you are a Columbus or Franklin County resident. These locations accept these materials free of charge only from residents. Professional landscapers are required to pay a fee to drop off yard waste for recycling.

The Ohio Mulch locations listed below are also accepting yard waste at no charge from Columbus residents.

Please be prepared with a driver's license or some form of documentation identifying you as a Columbus resident, otherwise you will be charged. Again, the Yard-Waste should include only organic materials from your own yard. Yard waste bagged in plastic will not be accepted. Posted signs referring to a \$12 fee do not apply to Columbus residents dropping off residential yard waste.

<u>Grass Clippings</u>: Returning grass clippings to the yard keeps your grass healthy and saves space in the landfill. In fact, grass clippings contain valuable nutrients that can generate up to 25 percent of your lawn's total fertilizer needs. Grass clippings do not contribute to thatch since grass clippings are 75 percent to 85 percent water and decompose readily.

<u>Composting:</u> Leaves, grass clippings, weeds, prunings, dead flowers and ash from burnt wood can be composted and not only to reduce yard waste, but nourish your landscaping. Composted materials provide important nutrients for soil and plants. <u>Do Not Burn Yard Waste:</u> Burning yard waste sends million of spores aloft, causes breathing problems for many sensitive individuals and is prohibited by local ordinances. Ohio Law further prohibits the burning of food wastes and other garbage. Also prohibited are the burning of any materials during an air pollution warning, as well as private burning of any items collected offsite. For example, a tree-trimming contractor may not haul branches and limbs to another site to burn.
