The Detroit Police Department is committed to uphold its mission to provide a safe environment for our residents and businesses. We appreciate and value the role our citizens have played in helping us to take the guns and drugs off the streets of the city of Detroit.

SPECIAL ENFORCEMENT ACTIONS

Narcotics/Gang Enforcement

During the period of June 30, 2008 through July 6, 2008, **Narcotics/Gang Enforcement executed 32 search warrants and 58 street enforcement actions** within the boundaries of the city of Detroit resulting in the following arrests and confiscations:

- 55 Felony arrests
- 106 Misdemeanor arrests
- 2 Juveniles detained

Confiscated:

- 405.80 grams of cocaine, 52.5 grams of heroin, 2,699.30 grams of marijuana, and 53 pills, with a total street value of \$268,147.20
- **\$ 18,191.00** in U.S. Currency
- 12 Handguns

Domestic Violence

On July 4th, officers of the Western District responded to the 18000 block of Prairie on a “Person Armed with a Weapon” and arrested a subject. Subsequent to the investigation conducted by members of Domestic Violence, the subject was charged with “Felon in Possession,” “Felonious Assault,” “Felony Firearm,” and “Habitual 3rd.”

Northeastern District

Officers of the Northeastern District responded to the 6000 block of Burns on "Two Persons Cut." Subsequent to the officers' investigation, a subject was arrested and later charged on June 30th, with "Assault with Intent to Murder," "Assault with Intent to Commit Great Bodily Harm," "Felony Assault," and "Habitual 4th."

**Western District**

On July 2nd, officers of the Western District responded to the 12000 block of West Seven Mile on a "Robbery Armed Just Happened." Due to the officers' quick response, three subjects were arrested and charged with "Assault with Intent to Rob While Armed." One of the subjects was also charged with "Felony Firearm." A handgun and personal property were recovered.

**Southwestern District**

On July 4th, officers of the Southwestern District responded to the area of Senator and Mullane on a "Shooting." Upon further investigation, a subject identified as the shooter was arrested. The subject was charged with "Assault with Intent to Commit Great Bodily Harm," "Great Bodily Harm," 2 counts of "Felony Assault," "Felon in Possession," "Carrying a Concealed Weapon," "Felony Firearm 2nd," and "Habitual 4th."

**Central District**

On July 4th, officers of the Central District responded to the area of Vinewood and Milford to assist a unit on a "Person Shot." As a result of the officers' quick response, two subjects were arrested and charged with "Carrying a Concealed Weapon." One of the subjects was also charged with "Felony Assault," "Reckless Use of a Firearm," and "Felony Firearm." Two handguns were recovered.

Northwestern District

On July 3rd, officers of the Northwestern District responded to the 7000 block of Clayburn on a "Robbery Armed" and arrested three subjects who were subsequently charged with "Carjacking," "Robbery Armed," "Felony Firearm," "Felon in Possession," and "Enter Vacant Dwelling without Permission."
