

Central District Significant Events

On January 9, 2009, at approximately 10:40 a.m., Central District Police Officer Renee Stanley, was on patrol in the Central District when the zone dispatcher gave a description of suspects involved in an armed robbery had just occurred at 5971 Grand River. The complainant was following the four subjects northbound on the John C. Lodge Freeway. Officer Stanley observed the wanted vehicle, a red 2003 Ford Focus wagon, occupied by four persons, exiting at Webb and awaited the assistance of Central 11 manned by Police Officers Chad Smith and Lamont Williams. Both units initiated a stop of the vehicle, activating their lights and siren, at

Elmhurst and Rosa Parks. The subjects pulled over and then put the vehicle in drive, jumped the curb and fled leading the officers on a vehicular pursuit through the Western District. During the chase the subjects disregarded several stop signs, red lights and drove at a high rate of speed. The subjects abandoned the vehicle at Roselawn and Lyndon with both crews giving chase on foot. Officer Stanley and Officer Stribbling, working Western District 144 took Mr. Garrett Peterson, b/m/16, who was driving the vehicle, into custody. Central District 11 apprehended Mr. Henry Donell Bell, b/m/46, into custody. Central District 31 manned by Police Officers

Clifton Whatley, and Damion Manning, took Mr. Frank Hills b/m/50 into custody. Western District 143 manned by Police Officers Phillip Long, Mark Zajac and Reginald Dyas, followed footprints in the snow that led to a vacant residence located at 14592 Roselawn. The officers gained entry into the location and took the last subject into custody. All subjects were arrested and conveyed to the Northeastern District for housing.



On January 15, 2009, at approximately 4:30 p.m., Central District Police Officers Derral Kelly and Karen Groom were working scout car Central District 14. They were dispatched to 484 Brainard on an assault and battery run. The officers arrived at the location and through their investigation found that the complainant, Mr. Jan Coyle was being held against his will by Mr. Eugene Williams, b/m/28. The officers requested backup and a supervisor. Central District Police Officers Thomas Grzywacz and Ryan Carruthers, working

Central District 44 and Central Sam 31 manned by Sergeant Leeray Stephens responded to the location. Sergeant Stephens initiated a dialogue with the perpetrator who refused to release Mr. Coyle. The officers heard someone in the residence yell, "He's cutting me" Sergeant Stephens, fearing for the safety of Mr. Coyle, gave the order to make entry into the location. They used the Haligan tool and forced. The officers found the Mr. Coyle lying on the floor, in a fetal position, in a pool of blood. He was bleeding from the

stomach. Mr. Williams was standing over the Mr. Coyle with a ten inch long knife on the floor next to him. The officers arrested Mr. Coyle was conveyed to Detroit Receiving Hospital by Detroit Medic 10, where he was treated for a stab wound to the left groin area. Mr. Coyle was listed in critical condition by Doctor Hasan..



Central District Significant Events (cont)

On January 22, 2009, at approximately 3:30 p.m., Central District Police Officers Raytheon Martin and Noe Garcia, were working scout Central District 135 (plain clothes/ unmarked vehicle), were in the area of W. Warren and Trumbull at when they received information from security of the Freedom Home Apartments that there was a fight at 1343 W. Warren in progress, and one man was armed with a gun. The officers arrived and observed three

black males walking to a vehicle parked in the parking lot. Officer Garcia observed a man, later identified as Mr. Devon Leroy Harrison b/m/20 was armed with a black handgun. The subjects got into a green, 1997 Buick. The officers approached the vehicle and Officer Garcia took Mr. Harrison into custody. Officer Martin investigated the other two subjects Mr. Alvin Mark Johnson, b/m/29, and Mr. Bennie Lavell Williamson,

b/m/19. Once the subjects were detained Officer Martin searched the vehicle and recovered a .357 Taurus, six-shot, blue steel handgun serial number# MF791545 loaded with three live rounds. Mr. Harrison was taken into custody and conveyed to the Northeastern District for housing.

On January 25, 2009, at approximately 4:00 a.m., Central District Police Officers Matthew Guigar and Mark Sievers were working scout Central District 11. The officers were on routine patrol when they observed a B/M (later identified as Mr. Roy Steven Flowers, B/M/40) standing (passenger side) near a blue Chevrolet Lumina in front of 440 Mt. Vernon. They approached the vehicle, and Mr. Flowers began to run N/B between the houses, holding his right jacked

pocket as if he was armed. Officer Guigar pursued him on foot and apprehended him in front of 451 Melbourne. Officer Guigar performed a frisk of Mr. Flowers and recovered six live R&P .357 rounds from his right front pocket. The officers returned to 440 Mt. Vernon. Officer Guigar followed path that Mr. Flowers had taken and recovered a fully loaded Colt .357 revolver. The weapon was recovered in the rear of 440 Mt. Vernon next to the fence that Mr. Flowers in his attempt to

flee. A LEIN inquiry revealed that Mr. Flowers was also wanted on a Central District Misdemeanor Warrant for Assault. He was arrested and conveyed to the District for processing.
