## Detroit Police Department

### Report to the Board of Police Commissioners

*The Detroit Police Department is committed to uphold its mission to provide a safe environment for our residents and businesses. This effort is not possible without the joint commitment of the community and the Police Department. We appreciate and value the role our citizens have played in helping us to take the guns and drugs off the streets of the city of Detroit.*

### Narcotics/Gang Enforcement

During the period of February 18, 2008 through February 24, 2008, **Narcotics/Gang Enforcement executed 39 search warrants and 33 street enforcement actions** within the boundaries of the city of Detroit resulting in the following arrests and confiscations:

- **42 Felony arrests**
- **112 Misdemeanor arrests**
- **4 Juveniles detained**

### **Confiscated:**

- **748.00 grams of cocaine, 53.1 grams of heroin, 1,258.20 grams of marijuana and 2068 pills, with a total street value:**
- **\$ 420,492.80**
- **\$ 14,152.00 in U.S. Currency**
- **15 Handguns**

# Police / Community Intervention

FEBRUARY 28, 2008

## NORTHEASTERN DISTRICT

On February 22nd, officers of the Northeastern District responded to the 6000 block of Fischer on a possible "Unlawfully Driving Away an Automobile & Kidnapping". Following an intense search by the officers, two subjects were apprehended and charged with sixteen counts of (1) Criminal Sexual Conduct, (2) Armed Robbery, (3) Carjacking, (4) Kidnapping, (5) Carrying a Concealed Weapon, and (6) Felony Firearm. In addition, one subject was also charged with "Felon in Possession" and "Habitual Offender 3rd."



## Domestic Violence

On February 19th, officers from Eastern District responded to the 10000 block of Peerless on "Domestic Violence" which resulted in an arrest. As a result of the investigation conducted by Domestic Violence, the subject was charged with (1) Felonious Assault, (2) Interfering with a Crime Report, and (3) Domestic Violence.

## NORTHWESTERN DISTRICT

On February 21st, officers of the Northwestern District responded to the 19000 block of Joy Road on a "Breaking & Entering of a Business." As a result of the officers' investigation, two subjects were arrested. Subject #1 was charged with (1) Breaking & Entering a Building, and subject #2 was also charged with (1) Breaking & Entering a Building and (2) Habitual Offender 2nd.

## CENTRAL DISTRICT

On February 20th, officers of the Central District responded to the 600 block of West Canfield regarding "Person Tampering with Gas Meter." Upon arrival and subsequent observations, the officers' arrested two subjects who were later charged with Public Utility Fraud.



## SOUTHWESTERN DISTRICT

On February 21st, officers of the Southwestern District were on patrol in the 4000 block of Braden when they observed a vehicle wanted in an "Armed Robbery." Due to the officers' keen observation, the subject was arrested and charged with (1) Assault with Intent to Murder, (2) Assault with Intent to Robbery Armed, (3) Assault with Intent to Commit Great Bodily Harm, (4) Felonious Assault, (5) Felon in Possession, and (6) Felony Firearm.
