

Tuesday, November 18, 2008

<u>Breaking and Entering (9100 block Of Mendota):</u> 1:30 P.M. Southwestern District's Patrol officers responded to a call of a "Breaking and Entering in process." Upon arrival, the officers searched the location, found two suspects inside the dwelling with a handgun in their possession. Both subjects were arrested and charged with possession of a handgun and "Entering Unoccupied Home Without Owner Permission (EWOP)".

Wednesday, November 19, 2008

<u>Home Invasion</u> (1400 block of Lansing): 8:00 P.M. A resident heard knocking at the back entrance door of his home and he went to answer the door. Three Hispanic Males wearing all black gloves and ski mask strong armed their way through the door; ransacked the house looking for valuables, demanded money and jewelry, while speaking in Spanish. *S.W.I.F.T (Southwestern Investigative Firearms Team), along with SWD Special Operations, made the location and was able to identify the suspects. Initially, only two (2) suspects were arrested. However, shortly thereafter, a description of the third suspect was given and the third suspect was arrested. All of the stolen property was recovered.

Thursday, November 20, 2008

<u>Purse Snatching</u> (Joy and Kentucky): 1:30 P.M. One suspect was arrested in a purse snatching robbery of a 64 year of woman leaving the market. She was approached by the suspect that asks her for the time, he then shoved her to the ground took her purse and ran. A witness that observed the incident called the police. The officers responded to the call and arrested the suspect.

Thursday, November 27, 2008



Breaking and Entering Business (6000 block of Tireman):12:20 p.m., SW11, received a police run to a business location. SW 11 approached the location they observed a blue Chevy Caprice in front of the business with the trunk opened and two black males exiting the business carrying a Craftsman Compressor. The officers observed forced entry to the front door of this location and investigated two subjects. Both were arrested and conveyed to the Schaefer Detention Facility for processing.

Saturday, November 29, 2008

Robbery (Grand River and Cloverlawn):12:20 a.m., SW21, were on routine patrol in the area of Grand River and Cloverlawn when they observed three juveniles strong arming an older male in the middle of Grand River. As the officers stopped to investigate the three juveniles began to flee on foot. SW 21 pursued the individuals and all were apprehended without further incident. SW21 returned to the scene and spoke with the victim, who stated that while at the bus stop, the subjects approached him, demanded money, and began to take the money he had in his pocket.

Sunday, December 7, 2008

Home Invasion (1900 block of Lansing): 12:00 p.m., SW5, responded to a police run, "Home Invasion in progress-men inside the rear door." The officers rapidly proceeded to the rear of the location, observed a broken window and two subjects attempting to flee from inside the location. The officers entered the home and pursued the suspects while still inside. Both subjects were apprehended and conveyed to the Southwestern Schaefer Station without incident. A warrant request was submitted to the Wayne County Prosecutor's Officer charging all three subjects with Home Invasion, First Degree.
