Turner provided a yearly report of the Atlanta Police Department. There were about 5 cars stolen near 201 Peyton Rd. in January. Many neighbors warmed their vehicles and did not lock them and they were stolen.</li> <li>• Within the MLK corridor, copper theft has been a big problem in this community.</li> <li>• Burglaries are down for the year. Sergeant Sherry to discuss 2100 and 2000 MLK across from cemetery issue with semi trucks and trailers.</li> <li>• 2630 MLK – Dept of Labor Parking lot. Numerous cars were meeting in this parking lot on Sundays. Police will continue to patrol and observe this area.</li> <li>• Overall, crime was up 4% but since Major Bryant has been assigned to this zone, crime has gone down by 4% at the end of the year, 2010.</li> </ul>
