b) 2010/2011 Neighborhood Improvement Projects Proposals & Vote

*Vice President, Noah Golinko, led the discussion for the proposed use of \$1750.00 in NIP Funds. The options were, as follows:

1. PRIMARY USE OF FUNDS

- Option 1: Buy neighborhood street sign toppers.
- Option 2: Fund up to \$250 for neighborhood watch and use the rest for sign toppers.

2. SECONDARY USE OF FUNDS

- Option A: Remaining funds go to the community garden.
- Option B: Remaining funds go to the general fund.

- *Ballots were passed out and the results of the voting were as follows:
- Option 1 received 8 votes.
- Option 2 received 41 votes meaning that we will fund a Neighborhood Watch group led by Carol Osterman up to \$250.00 to get established. The remaining funds will be used to buy street sign toppers.

^{*}Association member Matt Mahlke asked if the project was still open to bidding. John Silveira said that, if received in a timely manner, more bids would be accepted.

- Option A received 30 votes meaning that any remaining funds will be used to support the Citrus Heights Community Garden.*
- Option B received 9 votes.

*Association member and Community Garden member Gail Kobetich agreed to act as a liaison in coordinating the dispersal of any remaning funds to the garden.
