Thompson won wide acclaim during an illustrious career that spanned more than 60 years, during which she gravitated toward work portraying complex characters.

When you start off acting, it does seem very romantic, and the make-believe part of it all seems very exclung, she told the Los Angeles Times in 1991. "It's only later that you begin to realize how fascinating the work is - that it's a bottomless pit, and you never get to the end of it. Human character is just endlessly fascinating."

About 15 minutes before, Patrolmen Brian Molis and Jason Bolduc responded to a home at 21 Hopkins Street, and spoke with a 51-year-old victim who issued a complaint. He stated he had received a call to his cellphone at 11:17 a.m., though the caller didn't leave a message, which he deemed

Approximately 20 minutes later, he indicated he was in the first-floor bathroom when he heard footsteps climbing the stairs. When the victim went to investigate, he located the two suspects and asked why they were in his house, but they didn't answer and left via the front

Bolduc later contacted Dube and asked him to meet with the officer at a Lincoln skate park, and Dube agreed. Upon arrival, Bolduc met with Handy, who admitted to being in the residence with Dube earlier that morning.

'Handy stated that he initially took a \$10 bill from the dresser, but had second thoughts and placed it back on the bed," Bolduc wrote in his report. "Handy said that neither he nor Dube were given

permission to be in the house, and he was sorry for what happened."

After completing the investigation, Bolduc determined probably cause existed to believe a breaking-and-entering had occurred, and transported Handy to headquarters for processing. Molis, who had arrived at the skate park minutes after Bolduc, contacted Dube and placed him into custody.

Police arrested Jansler Santos, 18, of Cumberland at 11:45 p.m., Thursday, April 28 and charged him with larceny (under \$500) and vandalism/malicious injury to proper-
