## Welcome & Opening

- 1-a. The meeting opened about 7:05 P.M. and introductions by all were made.
- 1-b. The June 2010 minutes were accepted by consensus
- 1-c. Treasurer's Reports James K was absent, Leona reported there is \$34.90 in the bank account
- 1-d. IRS & tax status Armando presented the IRS' recommendation for the NWNA to file for 501(c)(4) status, a non-profit tax exempt status. Currently, NWNA is recognized as a HOA, i.e., for profit taxable group. For formal recognition it is a \$400 or \$800 fee or the group can operate as 501(c)(4) without filing an application, and must file returns each year. The motion to operate as a 501c(4) for non-profit tax exempt purposes without filing a formal application and to file our return per calendar year was passed. Armando will contact again the IRS to complete the appropriate paperwork. The treasurer will be responsible for filing NWNA IRS returns in March-April.

## NWNA concerns

- 3-a. Being inclusive with the "postcard" meeting announcement. SHARE print copies with neighbors.
- 3-b. Proposed changes to the Bylaws Leona D presented possible wording to include term limits to NWNA bylaws. Change was tabled to next month to allow input from more neighbors, Leona will distribute proposed change via listsery. The proposed wording is as follows, "An officer may not serve more than two consecutive one-year terms in any single officer position. If there is no candidate to oppose an incumbent, then the incumbent may remain in office for an additional term."
- 3-c. Armando presented several revisions he made to the Bylaws, including numbering Articles, detailing annual meeting in May, removing "chairperson" language that does not apply to us, and fixing a grammatical error. 3-d. Jefferson Park School will close. It is one of nine elementary schools being closed by TUSD. Jefferson Park serves our neighborhood..
- 3-e. Sewer vermin, a few neighbors had concerns, Ward III and County was contacted. No vermin were found. The speeders was tabled until the TPD is present. A concern about homeless receiving assistance in the 200 block E Lee.
- 3-f. Pan Left Productions was awarded a one-year Kresge Foundation grant for oral history! Meeting being scheduled.
- 3-g. Mansfield Park "Family" public art- Still no progress in finding the child's head or possible fix for the statue.
- 3-h. Active coyote in the neighborhood. Recent remains of domestic prey were found in the neighborhood.
