- 4-b. Gary Wittwer, COT-DOT, landscape for NWNA PCNR project
  - Landscaper has been chosen Southwest Enviroscapes Inc.
  - Landscaper can be paid to water plants ONLY through Dec 2011 per the IGA with Pima County. NWNA needs to decide how we can water plants for at least one or two summers, 2012 and 2013. There is approximately \$2,000 for materials that we could use for hoses, buckets, a 55-gal drum bike cart? Other ideas?
  - Chicane planting event, 10 AM-1 PM, Sa, 19 Feb 2011, 315 E Elm. Grading, planting holes and, possibly, boulders will be placed prior to this event. Gary or one of the landscape personnel will be there. Leona and James will pursue a cafecito grant for food for this event.

  - Work in progress still, Armando reported on interviewing Donna soon 5 March 2011.

- 4-e. Mansfield Park sculpture
  - "Family" sculpture update Armando reported from TPAC that City Parks and Rec has allocated \$600, for two artists and materials, to repair this sculpture. Timeline unknown at this time.
- 4-f. 6<sup>th</sup>/Linden
  - "neighborhood sign/community board," an unaccomplished item from PRO Neigh's grant Dan presented the idea of two low-level wooden pocket park signs on steel posts, for the approximate cost of \$250-\$350. The neighbors agreed by consensus to pursue this idea through one of the \$500 PRO Neighborhoods grants BUT we need to find five neighbors who were not on a previous grant. Who are these neighbors and will they be amiable?

Armando will pass this suggested on to Tom.

## NPZ concerns and Administrative Action taken

7-a. NPZ concerns from NW neighbors – Armando reported that several neighbors would like to see some sort of NPZ process for NWNA, and protection from more mini-dorms in the NWNA area. 7-b. Guests: Bob Schlanger and Joan Hall, JPNA

Bob presented Jefferson Park NA's experience in applying for National Historic Status and the NPZ process. JPNA has worked with Council Member Uhlich to produce a legal document claiming that Goodman properties are "group dwellings"- not allowed in R-1 or R-2 zones. This formal Request for Determination, an administrative action allowed under the Land Use Code and zoning ordinances, has been submitted to the Zoning Department. The COT attorney advises several COT boards, commissions, committees and departments including Zoning. Prop 207 does not affect this formal request nor the city's ability to take action against developers who misuse the Land Use Code because the "group dwellings" definition pre-dates Prop 207. The JPNA is awaiting for a response to its request from the Zoning Examiner. The response is currently four weeks overdue. If the wait continues, the JPNA will request that the request go before the Zoning Commission and seek additional help from Uhlich in pursuing further action.

The JPNA recommended NWNA to submit its own Request for Determination to the Zoning Examiner, and JPNA can provide assistance in writing this request. They are also requesting money (estimate \$10,000) to pay the lawyer (who lives in JPNA and had been doing some legal work pro bono) and pay other related expenses. Contact Bob to join a confidential email list regarding this multi-neighborhood concern.
