Home Improvement Plans...

If you are considering home improvements such as fencing, home expansion or any exterior change, pool, etc., send in your plans for approval to the Association before you begin. The Association's Protective Covenants require prior approval before any construction begins.

Please submit by email: ALL construction plans, materials, colors and plot plan, if necessary, etc. to Property Manager.

The Board has 30 days to review and consider the submitted plans but in most cases render a decision quickly. Obtaining Board approval does not absolve the homeowner from getting other agency approvals.

- •Signage of any kind in common landscaped islands is **prohibited** and only professional signs are permitted on any lot."
- (Signs will be removed if seen and taken to City Maintenance Building on South Loop Rd.)
- No recreational vehicles, boats, or travel trailers can be stored or parked more than 48 hrs. during any calendar month.

- LEAVE your post light on during hours of darkness and your outside lights on during the evening hours.


Block Party....???
