ARTICLES OF INCORPORATION

We, the undersigned, being natural persons of the age of twenty-one (21) years or more and incorporators of the corporation to be organized pursuant hereto, for the purpose of forming a corporation under the "General Not-For-Profit Corporation Act", Chapter 355, R.S. Mo., 1965, as amended, do hereby adopt the following Articles of Incorporation.

ARTICLE ONE

The name of the corporation is KEHRS MILL ESTATES RESIDENTS ASSOCIATION.

ARTICLE TWO

The corporation is formed for the following purposes:

To act as a Trustee for the Kehrs Mill Estates Subdivision, St. Louis County, Missouri, and in the capacity of Trustee to acquire and hold title to such common areas and to carry out all of the duties delegated to it as a Trustee, including but not limited to the collection and disbursement of funds for any authorized purpose of the Trustee; to act as a homeowner and community improvement association; to supervise, maintain and improve the common areas in said Kehrs Mill Estates Subdivision, for the use, benefit, protection, enjoyment, welfare, health, safety and recreation of the residents of

said Subdivision; and to do all other things and acts necessary or conducive to the carrying out of the aforesaid purposes and the powers and duties granted to it as Trustee of Kehrs Mill Estates Subdivision.

#### ARTICLE THREE

The duration of the corporation is perpetual.

ARTICLE SEVEN


The members shall have no right to vote except as specifically set forth in the By-Laws of the corporation.


ARTICLE EIGHT

Provisions for the regulation of the internal affairs of the corporation, including any provision for distribution of assets on dissolution in final liquidation may be made in the By-Laws of the corporation; provided, however, that the members of the corporation shall be those persons who are the lot owners of Kehrs Mill Estates Subdivision; said memberships being appurtenant to and in conjunction with the ownership of lots in said Kehrs Mill Estates, and any conveyance or change of ownership of any lot or lots in Kehrs Mill Estates shall carry with it membership in the corporation. No member shall have a right to convey his membership in the corporation except as an incident to the ownership of a regularly platted lot.
