WHEREAS, according to Section 5, *Amendment*, of Article XII of said Declaration, Members possessing at least two thirds (2/3) of the total number of votes possessed by all Members have the right to execute an amendment to said Declaration and file said amendment on the public records of Indian River County, Florida; and,

WHEREAS, as of the date of the execution of this document, WESTMARK

WHEREAS, Developer is in possession of at least two-thirds (2/3) of the total votes of all members of Stonebridge Subdivision; and

WHEREAS, Developer desires to amend Paragraph #17 of the ARCHITECTURAL CRITERIA, which is attached to the Declaration as Schedule "A".

NOW THEREFORE, Developer amends the MASTER DECLARATION OF COVENANTS, CONDITIONS, RESERVATIONS AND RESTRICTIONS OF

1. Paragraph 17 of Schedule "A", ARCHITECTURAL CRITERIA, of the Declaration shall be amended to read as follows:

- "17. SOLAR PANELS. A limited number of solar panels are permitted, but a large number of panels renders the roof unsightly and detracts from the aesthetic image of the house and neighborhood. The area devoted to solar panels should accordingly be in reasonable and minor proportion to the area of the section of the roof on which they will be installed and, where possible, attached to the least conspicuous part of the roof and must not be seen from the roadway. Specific approval of the solar panel design must be obtained. Heating of pools with solar panels is allowed with the approval of the ARC."
- 2. Except as specifically amended herein, in all other respects, the MASTER

 RESTRICTIONS OF STONEBRIDGE SUBDIVISION, as previously amended, shall remain in full force and effect and are ratified and confirmed.
