Picking up trash, toys, and debris

We are encouraging each resident to clean up around the outside of their home each day. Keeping the outside of your home clean sends a message of neighborhood pride.

Reducing Speed

We are asking that all residents, and guests, reduce your speed as you drive through the neighborhood. Obeying the speed limit will help ensure the safety of children playing outside.

Reminder of City Code Violations

Trash Containers

Solid waste containers left outside, empty or full, must be stored behind the existing building line and be screened from view from the street or any neighboring property. This maintains the appearance and value of our homes.



Trash Dumping

Dumping of trash, junk, limbs, grass or other yard waste on private property or in a storm drain is prohibited. This may cause water to back up and eventually cause flooding.

Trash Pick-up

Containers may be placed in front of your residence or next to the street no more than 24 hours before your scheduled trash pick-up. This improves the appearance of the neighborhood, prevents trash from blowing, and keeps animals from getting into it.

Note: We would like to emphasize that safety is a priority in this neighborhood, particularly for children. Residents are asked to drive and park safely.
