**Introductory Local Law #1-2012**

**A local law to override the tax levy limit established by General Municipal Law Section 3-c.**

**PLEASE TAKE NOTICE** that the Town Board of the Town of Ogden will hold and conduct a public hearing upon Introductory Local Law No. 1 - 2012. The Town Board will hold and conduct such public hearing at the Ogden Community Center, 269 Ogden Center Road on the 14th day of November 2012 at 7:30 p.m., at which hearing all interested persons shall be heard concerning the subject matter thereof.

The proposed local law proposes to allow the Town Board to adopt a budget for the fiscal year 2013 which may exceed the tax levy limit as defined by the provisions of General Municipal Law Section 3-c. The proposed budget for the fiscal year 2013 as calculated pursuant to the regulations of General Municipal Law relating to tax levy limits does not exceed the tax levy limits as calculated by the Town of Ogden. The adoption of this local law is to provide for a safety net to the Town of Ogden in the event that the NYS Department of Audit and Control shall subsequently determine that the fiscal year budget for the Town of Ogden as adopted for the calendar year 2013 shall, pursuant to the terms of their calculations, exceed the tax levy limit.

All interested persons shall be heard concerning the subject matter thereof. A full and complete copy of such local law is presently on file in the Town Clerk's Office where it may be examined during normal business hours.
