Cold Weather Practices

ohnson County PARTNERSHIP FOR WATER QUALITY has produced a great pamphlet for use in our neighborhood. This was handed out in our first annual meeting on November 10, 2012, by guest speaker, Richard DeWitt, who is Franklin's Storm Water Coordinator. Mr. DeWitt addressed our water runoff from our lots to our four (4) lakes. Here are some of the tips made in this handout:



"Winter brings with it lot of fun activities - like sledding, ice-skating and skiing. The winter also means mounds of snow to shovel and layers of slippery ice to remove from our sidewalks and driveways. We often attempt to make the job easier by using various products like salt to melt the snow and ice. Besides sodium chloride, many deicers may often contain chemicals like cyanide. When the ice melts, the salts and chemicals dissolved will flow into our street drains" which go to our lakes - and eventually to the Youngs Creek Basin, endangering all aquatic life. Here are some tips:

- ♦ Shovel early and often. There is no substitute for muscle and "elbow grease"! Deicers work best when only a film layer of snow or ice must be melted. So head out and shovel, and try to move as much as you can during the storm, if possible.
- Reduce your salt use. Calcium magnesium acetate is an alternative, because it has no adverse environmental impacts, and this salt doesn't cause corrosion.
- Reduce the use of sand. Sand doesn't melt ice, it simply provides traction. But through storm water, sand will increase the amount of sediment that is in our lakes and creek basin degrading or eliminating important habitat for aquatic organisms.

The FLHOA Budget is **Enclosed!**

ast December 10th, at the Franklin Lakes Homeowners Association's (FLHOA) Annual Meeting, the 2013 Budget was passed unanimously. We have strived in the past three (3) budgets to obtain a \$6,000 surplus by the end of this fiscal year - by having our single fee stand at \$135.00 per year. It is our hope to maintain such a surplus in case we were to have an emergency (e.g.—a dam leak in one of our four (4) lakes (Blue Heron, Whispering Pine, Walden and Glistening Emerald).

In the past three (3) years, we have increased our liability insurance amount with a \$5,000 deductible. This covers our entrances (with brick walls and illuminated signs and our common owned lake properties (the dams on our four (4) lakes which is where you can walk "from bird box to bird box".
