### **Meeting Minutes**

## January 11, 2011

#### !. Welcome

Meeting chair Clara Zahradnik welcomed CS/TNA meeting attendees.

#### 2. Committees

- Wilmington Clean-up Day in April. Since the city will not have special clean-up activities due to
  cost constraints, officials have asked the communities to organize clean-up projects. Ideas for
  Cool Spring/Tilton include renting a mini-dumpster for the neighborhood. Please sign up to be
  involved.
- Community Yard Sale in May. Ideas include a bazaar-type event in the Cool Spring Plaza Circle with music and food.
- Streetscape around Cool Spring Park. CS/TNA has an opportunity to apply for \$500,000. in government funding to improve the streetscape including trees and grass (not the interior of the park) and following the master plan in this two-year project. The neighborhood association must raise \$50,000. in grant money to contribute as well as complete and submit an application within one month.

#### 3. Community Gardens

West Side Grows is an initiative of residents of Cool Spring, Tilton, and other West Side neighborhoods in partnership with Public Allies and Cornerstone West and is working to establish community gardens on the West Side of Wilmington. Rodney Street Reservoir and Father Tucker Park have been identified as possible sites.

### 4. 1109 North Franklin Street DRPC Hearing

Peter von Glahn and Clara Zahradnik will propose changes to the exterior of their home (1109 North Franklin Street) to the DRPC in late January and for informational purposes, Peter von Glahn presented the proposed modifications to the CS/TNA. Renovations of the kitchen will result in minor exterior changes including modified window sizes and replacement of double-hung windows with casement windows which will be replicas for the original casement windows.

A motion to accept the changes was proposed, seconded, and voted in favor by all attendees. This presentation should serve as a model for informing the community of changes to houses by owners that will be proposed to the DRPC at a later date.

### 5. Wilmington Police Department

Several members of the Wilmington Police Department (names below) reported on public safety issues in Wilmington and specifically in Cool Spring/Tilton neighborhoods.

Don Bluestein, West Side Supervisor, presented an overview of the police activity on the West Side which encompasses west of Market Street and south of the Brandywine River to the city border. Each platform has 30 officers with the goal being for each officer to spend as much time in his/her home territory as possible.

Officer Michael Fossett described the Community Police effort in the Cool Spring/Tilton neighborhood. Contact information is attached.

Community Police officers answer non-emergency calls (for example, a car that has not been moved in three days and may be stolen) in contrast to Patrol Police who handle 911 (emergency) calls. Non-emergency complaints should be directed to the community police officers or 654-5151 (non-emergency police number) so that the complaint can be logged into the police computer system. If a resident calls 654-5151, this should be followed up by contacting one of the Community Police officers.

Three officers are currently assigned to Cool Spring/Tilton neighborhoods:

Their area is Lancaster Avenue to Pennsylvania Avenue and Jackson Street to Union Street with three shifts (day, night, and midnight).

Questions by attendees and recommendations by Officer Fossett included:

- Neighborhood Watch Committee should contact whom regarding suspicious activity?
   Recommendation: If participants see any suspicious activity during the rounds, call the
   Community Police officers since 911 prioritizes complaints and may not be as immediately responsive as Community Police officers.
- Loitering is frequently seen at 8<sup>th</sup> and Jackson Streets and other locations. What should we do? Recommendation: Contact Community Police. Community Police officers can focus and spend more time on a problem such as loitering. A specific address is needed. Any information such as hiding places for drugs (including trash cans or hole in a brick wall) is important to convey.

Police Chief Michael J. Szczerba provided recommendations for crime prevention:

- Keep an eye out for the safety of neighbors and houses.
- DO NOT leave anything in plain view in a motor vehicle since thieves may mistake an
  inexpensive item for something more valuable and break into the vehicle to steal it. For
  example, a cheap calculator may look like an expensive GPS device; a gym bag may look like a
  handbag with money in it to a thief. The thief breaks a window to get what he/she thinks is
  valuable.
- Keep lights on outside of houses and businesses to deter thieves.

In the Cool Spring/Tilton neighborhoods, motor vehicle break-ins are on the rise. Crime increases and decreases depending on who is in jail at the time. Vandalism and theft have occurred in Cool Spring Reservoir Park.
