Please refer to the following sections of the Code of Regulations:

• Page 6, Article III, Section 2C that assigns the Council responsibility for:

"C. Providing for the operation, care, upkeep, maintenance, and surveillance of all the Common Elements and services of the condominium."

• Page 9, Article III, Section 14:

"Section 14, Committees.

The Council may establish and staff committees to assist the Council as directed. Committee assignments may include the conducting of studies and the planning and execution of functions. Committees may be composed of any individuals deemed qualified by the Council"

Page 20, Article VII, Section 8:

"Section 8. Rules and Regulations. Rules and Regulations concerning the operation and use of the Common Elements may be promulgated and amended by the Council, provided that such Rules and Regulations are not contrary to or inconsistent with the Unit Property Act, the Declaration or this Code of Regulations. Copies of the Rules and Regulations shall be furnished by the Council to each Owner prior to the time when the same shall become effective."

Recent unauthorized decorating of interior halls necessitates initiating the attached rule and regulation. This is initiated to insure that the Common Elements are maintained to our current high standards and prevent inappropriate decorations.

A loose leaf notebook will be initiated in the third floor book case of both buildings in which this and any additional rules and regulations will be placed. In addition, a copy of our Code, Declaration and the State Law governing condominiums will be included.

Carillon Crossing Rule and Regulation <u>Decoration of Common Elements</u>

- 1. Each Building's Decoration Committee will be responsible for the decorating of Common Elements in their respective building.
- 2. A budget will be provided for each building for decorating. The Decorating Committee will have the discretion to use the budget money as they feel to be appropriate.
- 3. Any CCAO funds required for decorating above and beyond the budgeted amount must be requested by the Committee from the Council.
- 4. Gifts or loans such as pictures, furniture, lamps, etc are welcome. However, before placing such in Common Elements, the involved Building's Decorating Committee must be contacted by the donor. The Decorating Committee will determine if the item is appropriate. If not appropriate, the item will be rejected.
- 5. Any items that are in the Common Elements at the time of the issuing of this rule and regulation will be reviewed by the Decorating Committee. Any items deemed not to be appropriate will be removed.

Carillon Crossing Rule and Regulation Purchases/Financial Commitments

Following are the procedures to be followed on the subject:

- The CCAO budget will outline the financial guide for annual expenditures for each expense.
- 2. The Decorating and Social Committees have the discretion to use their budget money as they feel to be appropriate.
- 3. Annual, multi-year or evergreen contracts must receive approval from CCAO Council prior to commitment. Execution shall be by any two officers of CCAO.
- 4. All spot contracts and purchases having a value of \$1,000 or greater must receive approval from CCAO Council prior to commitment. Contracts shall be executed by any two officers of CCAO.
- Except for purchases as shown in above step 2, spot contracts and purchases having a value under \$1,000m must receive approval from two officers of CCAO prior to commitment. Contracts shall be executed by any two officers of CCAO.

Carillon Crossing Rule and Regulation Interest/Late Payment Penalty

<u>Interest</u>. In the event of a default by any Owner in paying any Common Expenses or other sum assessed against him which continues for a period in excess of thirty (30) days from date of invoice of any Common Expense, such Owner shall be obligated to pay interest of 18% per annum from the due date thereof; unless such interest is waived by the Council.

<u>Late Payment Penalty</u>. In the event of a default by any Owner in paying any Common Expenses or other sum assessed against him by due date thereof, such Owner shall be obligated to pay a late fee of \$25.

PARKING AT CARILLON CROSSING

Our Code of Regulations, Article VII, Section 10, Parking Spaces states:

"Parking shall be governed per the Rules and Regulations adopted by the Council. The cost of maintenance and repair of all parking areas shall be a common expense."

CARILLON CROSSING PARKING RULES AND REGULATIONS

PARKING PROCEDURES

- There are two types of Parking spots:
 - "Open" (not covered) -46 spots including 10 designated for visitors and three for handicap
 - " Covered " (deemed appurtenant to a unit and so recorded on unit deed) -22 total
- Parking shall be governed by Council and Council shall assign preferred open parking spots (near buildings).
- Each resident having an automobile on site is entitled to either a covered spot or a preferred open spot.
- An owner may allow use of a covered spot by another resident.
 However, the covered spot will be considered as the assigned spot for the user's unit.
- If a preferred open spot is vacated (e.g., resident no longer has a car or resident has moved), Council can reassign it.
- Requests of residents will be considered, when Council assigns spots.
- Handicap parking spaces are limited to <u>visitors</u> with displayed handicap placards or license plates. The use of these spots by handicapped <u>owners</u> as secondary owner spots is prohibited. However, short term parking by handicapped owners for loading/unloading is permissible. The essence of this condominium rule was originally established by Senior Life Choice and Carillon Crossing's Council during the early days of our history.
- All unassigned open spots are available to additional cars of residents and visitors.
