CALL TO ORDER:

Jerry Garfield called the Board Meeting of the Stanton Farms Townhomes Association to order at 6:58 p.m.

HOMEOWNER INPUT:

10329 A: Board stated that they did not approve patio project. Owner asked about letter from Management Trust dated 8/27/2012. Bob explained that letter was sent without authorization using stored signature in computer. Owner wanted to know why she was not notified that letter was sent without authorization. Owner requested all correspondence regarding the ACC request. Board authorized Management Trust to provide documents to owner.

Jerry addressed concerns of owner of 10547-A. He explained purpose of backfilling units and necessity to resolve water drainage issues before repairing other items. Discussed why board has requested that air conditioner unit pads must be raised and window collars installed. Jerry invited homeowners to join him on property walk thru on Thursday, April 11 with Western Maintenance. Lengthy discussion on maintenance issues, how prior year dues and reserves were inadequate to maintain and repair property plus. Jerry discussed effect of inflation on maintenance costs.

The board approved and ratified the March 2013 Meeting Minutes as presented.

The board approved and ratified the March 2013 Financials as presented.

UNFINISHED BUSINESS:

Towing Agreement: Board agreed that discussion no longer needed.

Board noted that maintenance covenant required to be filed when new decks, patios, and fences are installed by homeowner.

Board asked that Maintenance agreement be brought to the next meeting

NEW BUSINESS:

Vandalism - Board noted that security cameras explored in past. Board decided not to install them due to expense and no place to store computer needed to support it.

Trash and other covenant issues discussed. Jerry explained that trash removal addressed by covenants and trash cans must be stored out of site. Jerry noted that covenants allow pets subject to local ordinances but do not specify limits or duties of pet owners to other homeowners. Jerry stated board should consider policy of limiting 2 dogs per household. Jerry noted that parking space is limited and the covenants specify that vehicle and RV storage is not allowed.

Rental units: Board is concerned that units occupied by renters have numerous violations. Requested that Bob provide options for covenant enforcement when units occupied by renters. Bob explained that board has jurisdiction over homeowners only. Bob recommended that rental agreements incorporate obedience to declarations and association rules. Notice of these items to renter strengthens owners' position. Board requested written recommendations.
