SUBJECT: Neighborhood Watch Program

In 2004 Glen Eves established a Neighborhood Watch Program in cooperation with the City of Roswell Police Department. The program has been successful and, overall, we have kept our neighborhood safe.

We have several new residents to Glen Eves and we welcome you! In case you haven't previously participated in a Neighborhood Watch program, here is a quick overview. Neighborhood Watch is a citizen's involvement program where citizens, in cooperation with their local law enforcement agency, directly participate in the detection and prevention of crime. Citizens learn to recognize suspicious or criminal activities and report them to their police department. They keep well informed about their neighborhood and of any suspicious, criminal or dangerous activities that may be occurring. Neighborhood Watch can and will make our community a better and safer place to live.

Block captains are responsible for relaying information to members on their block and keeping up-to-date information on residents. They also serve as liaisons between the neighborhood and the police and communicate information about meetings and crime incidents to all residents. **Please get to know your block captain as well as your neighbors.** This is the key to the success of this program because your ability to detect suspicious activities first starts with you knowing the neighborhood or block.

We have seven block captains in place, and we owe them a big *thank you* for volunteering to serve in this important position. They are Eric and Leslie Brown; Susan Fritts; Dan Leach; Ingeborg Mack; Linda Poolos; and Curtis Richardson.

Following is some helpful information about how to report suspicious activity in our neighborhood:

If you see suspicious activity, please call the Roswell Police Department at <u>770-640-4100</u>. Ask them to send an officer out. If you call this number after 5:00, it will roll over to an operator in the 911 Center, but will not come in as a 911 call.

However, in the case of an emergency, always call <u>911</u> first. An emergency is when immediate police, fire department, or paramedic assistance is necessary to save and protect life or property.

A suspicious activity occurs when a person's conduct or action does NOT FIT the norm of your neighborhood or the surrounding circumstances. It is when your attention is drawn to a person's conduct that is unusual, different, odd, dangerous, appears wrongful, or not-just-right under the circumstances. It is an occurrence that is out of place and should not be happening in your neighborhood under normal circumstances. You should call the police *any time and every time* you think something is wrong, dangerous or suspicious. No exceptions!

Remember, a Neighborhood Watch program is only as successful as its participants, so let's all continue to be diligent in keeping our neighborhood safe and secure. Know your neighbors, be observant, keep informed, and know that you can make a difference.
