WHEREAS, SUBURBAN DEVELOPERS, INC., a Texas corporation did file and cause to be recorded in Volume 4305, Page 270 of the Plat Records of Bexar County, Texas, a plat of certain properties designated as Oak Haven Heights, Unit 3 Addition, an addition in Bexar County, Texas; and,

WHEREAS, on the 13th day of February, 1963, Suburban Developers, Inc. did cause to be recorded by its proper officers, certain restrictions affecting said Oak Haven Heights, Unit 3 Addition.

NOW THEREFORE, WE, the undersigned, being a majority of the owners of all of the lots in Oak Haven Heights, Unit 3 Addition, for the purpose of amending all restrictions effecting Oak Haven Heights, Unit 3 Addition here now agree that the following Corrected Restrictions shall apply to all of the lots of said Oak Haven Heights, Unit 3, Addition as hereinafter set out; said Lots being:

- All structures of whatsoever nature erected or placed on all lots in said subdivision shall be of new construction only, and shall be constructed on-site with new materials only, and shall conform to all other requirements hereinafter set forth.
- All lots of said subdivision as evidenced by the map or plat thereof shall be used for residence purposes only, and no part thereof shall be used for business

purposes nor any other structure whatsoever, other than a single-family residence, with the customary outbuildings, garages and servant's houses, provided however, that no servant's house, outbuilding or garage shall be lived in as a home, SAVE & EXCEPT Lot 21, Block 31 Oak Haven Heights, Unit 3, which has been reserved for future expansion of the water distribution system intended to serve Units 1, 2, and 3 of Oak Haven Heights Addition, and including, but not limited to, a water well, pumps, storage and/or pressure tanks and such other equipment as may be necessary for the proper operation of said water distribution system should such expansion become necessary for proper water service to users in said additions.

- 3. That no residence shall be erected upon said lots which does not contain at least One Thousand Five Hundred Fifty (1,550) square feet, exclusive of open porches and garages, with at least seventy-five (75%) percent of the first level of said structure constructed of brick, rock, concrete, or masonry materials.
- 4. Each residence shall be constructed with at least a single car garage, attached or detached, from the residence and a paved driveway from the garage to the street.
- 5. No noxious or offensive trade or activity shall be carried on upon any lot, nor shall anything be done thereon which may be or become an annoyance or nuisance to the neighborhood.
- 6. All buildings of frame construction and all fences built of new lumber shall be painted with at least two coats of paint.
- 7. No building shall be located nearer to the front lot line or nearer to the side street line than the building set back lines shown on the recorded plat. In any event, no building shall be located on any residential plot nearer than 30 feet to the front lot line, and no building, except a detached garage or other outbuilding located 60 feet or more from the front lot line, shall be located nearer than 5 feet to any side lot line.
- 8. No outside toilets shall be installed or maintained on any premises and all plumbing shall be connected residence and a paved driveway to the street.
- 9. That the designated owners herein, their successors or assigns shall not use the above described premises, nor any part thereof, or allow same to be used for treating persons afflicted with tuberculosis or diseases that are contagious or infectious, nor shall any sanitarium ever be erected or placed thereon for any such purpose.
- 10. No trailer, mobile home, modular home, pre-fabricated home, basement, tent, shack, garage, barn, or other outbuilding erected on any of said lots shall be at anytime be used as a residence temporarily or permanently, nor shall any structure of a temporary character be used as a residence.
- 11. No animals, livestock, or poultry of any kind shall be raised, bred or kept on any lot, except that dogs, cats, or other household pets may be kept provided that they are not kept, bred, or maintained for any commercial purpose.

- 12. No lot shall be used or maintained as dumping ground for rubbish. Trash, garbage or other waste shall not be kept except in sanitary containers. All incinerators or other equipment for the storage or disposal of such material shall be kept in a clean and sanitary condition.
- 13. No sign of any kind shall be displayed to the public view on any lot except one professional sign of not more than one square foot; one sign of not more than five square feet advertising the property for sale or rent; or signs used by a builder to advertise the property during the construction and sales period.

These covenants are to run with the land and shall be binding on all parties and all persons claiming under them until June 1, 1988, at which time said covenants shall be automatically extended for successive periods of ten (10) years unless by vote of a majority of the then owners of the lots of said subdivision, it is agreed to change said covenants in whole or in part.

If the parties hereto, or their assigns, shall violate or attempt to violate any of the covenants herein contained, it shall be lawful for any other person or persons owning any real property situated in said subdivision to prosecute any proceedings at law or in equity against the person or persons violating or attempting to violate any such covenant, and either to prevent him or them from doing such, or to recover damages, or other sues for such violations.

Any pre-existing structure, built or under construction on the recording date of these Amended Restrictions shall be deemed to be in compliance with these Amended Restrictions.

Invalidation of any of these covenants by judgment or court order shall in nowise affect any of the other provisions which shall now remain in full force and effect.

The undersigned being a majority of the legal owners of all of the above described property, herenow, by the execution of this instrument, give our consent to the restricting of said property as provided herein.
