## Old Business:

1. Fine Policy Application
a. 2967 Brookwood Drive- $\$ 100-$ As of the meeting the fine has not been paid. The Board believes that at this time the homeowner, Doug Buck is in compliance with the covenants. The Board will continue monitoring the home.
2. Covenant Violations-
a. $\quad 1449$ lvy-truck topper-MVAS will send a letter.
b. 1336 Centennial Road- wood pile-MVAS will send a letter.
3. Lake Access Maintenance-
a. Deck boards and Split rail fencing-north access
b. -Chris Demmler and James Holley will address the repairs and report at the next meeting.
c. Split rail fencing-south access posts-Chris \& James will look at the center post and repair it.
d. Mowing-Randy Cain-The Board is expecting to utilize Randy's service in the spring.

## New Business:

1. 2013 Calendar of Events-The Board reviewed the calendar of events. MVAS noted that there are 3 City of Fort Collins Grant deadlines this year. The first grant applications and details are available on February $1^{\text {st }}$. The dates of the deadlines are: March $15^{\text {th }}$, July $2^{\text {nd }}$ and August $16^{\text {th }}$. Marilu Smith had filed the grant applications for the HOA and had volunteered to host this year's Neighborhood Nite Out. The Board opted not to do the Garage Sale since the participation is so low. Caroline Koff has the garage sale signs.
2. MVAS 2013 Contract- JoAnn Brown presented the contract for this year for the Board's review. The annual minimal cost is $\$ 1133$ plus hourly expenses. Split rail fencing-north access Split rail fencing-north access. —Howard Kendrick moved to approve the 2013 MVAS contract and Dick Bader seconded the motion. The motion carried.
3. Lake Sherwood Corp 2013 bill $\$ 2057$ - $\$ 17$ per unit 2014 bill \$2662- $\$ 22$ per unit 2007 bill \$1996.50 16.50 per unit
MVAS received a phone call from Dennis Sumner, the treasurer of the Lake Sherwood Corp. He said that the Lake Corp. is planning a \$5 per unit increase next year. MVAS calculated the increase from the last increase in 2008 based on what she believes was limited to a $2 \%$ increase per year. If that is indeed the case the Lake Corp. cannot increase the assessment to not more than \$2314 per year or approximated $\$ 1912$ per unit. Dennis also noted that Rich Shannon, Lake Corp.
president and SVHOA homeowner, was adamant that the Board give each HOA more notice and opportunity for input. MVAS noted that the cost of doing a second billing would be very costly to the HOA. MVAS emailed Rich Shannon to inquire about the specific document that shows just how much the Lake Corp. can increase the assessment each year. Diane Kenning will look in the files to see if there is anything about the increases that the Lake Corp. is limited to each year.
