Our June meeting was very well attended – members and residents from Woodlawn and Yonkers filled the cafeteria. The City of New York Dept. of Homeless Services and the Doe Fund were represented by Lisa Black, Director of Government Relations and John McDonald, COO of the Doe Fund. Ms Black provided an overview of what NYC does for the homeless population. By NYC law, if you are homeless, you have a 'right of shelter' and NYC is legally obligated to find you a place to sleep. There are over 50,000 homeless in NYC & 21,000 are children. NYC operates 250 shelters.

Mr McDonald explained that the Doe Fund is a 9

to 12 month transitional work program for homeless men to obtain a full-time jobs. Ms Black and Mr McDonald stressed that this shelter will house veterans of our Armed Forces. They promised that it will be a secure facility and that all residents go to work each day.

Our community is very upset that this shelter and another which is being built across the street from 555 Nereid Avenue called **Project Renewal**, are both being placed in our community. **NYC** is creating a saturation of homeless.

Our elected representatives while supportive of our concerns have so far been unable to prevent NYC from continuing with its plans. This saturation of shelters is critical issue upon which Woodlawn and Yonkers voters will decide for whom to vote for in the next election. As of this writing, we have still been unable to learn if the federal government has transferred the Mueller site to NYC.

In June, Woodlawn resident Kevin Bell was killed in a fatal hit and run accident on East 233rd Street.

Our prayers and thoughts are with his parents and family. This tragedy was further compounded by the disgraceful behavior by the OCME unit which responded to the scene of the crime. In conjunction with the Emerald Isle Immigration Center and this Association, NYPD Deputy Inspector Brian Mullen held a meeting with community leaders and briefed us on what had occurred. The investigation is still on-going. The OCME choose not to attend this meeting. As a result of community outrage and with the support of Councilman Koppell, a hearing was held at City Hall and the driver was suspended for 30 days without pay and the unit and its supervisors will be now required to go through sensitivity training. We believe that not only should the driver have been suspended but the OCME managers and commissioners should be accountable for the disrespect shown for the deceased.

Graffiti vandals have defaced St Barnabas elementary school and the parish center as well as private property throughout the neighborhood. Vandalizing religious institutions is a serious biascrime and should be punished to the fullest extent of the law.
