FY 2014 Legislative and District Highlights

- Passed a Ban the Box Ordinance, prohibiting Metro Louisville from asking about prior convictions on city, vendor and contractor job applications
- Passed an ordinance limiting the sale of retail package liquor to 2 a.m. across Metro
- Passed a resolution urging the Ky General Assembly to restore voting rights for people who have completed their sentences
- Adjusted the Louisville Arena Authority TIF boundaries to increase the Arena's profitability and debt service coverage
- Introduced a resolution presently in committee for a moratorium on boarding, transitional and rehab housing in District 5 pending further study.

"Shine on Shawnee" Small Business Development Update
Eight small businesses in the Shawnee neighborhood have received microbusiness loans totaling \$71,000 to help them expand. These loans assisted two child care agencies, a cleaning service, and several home-based businesses including a magazine featuring West Louisville news. The targeted efforts in Shawnee, part of the Shawnee Neighborhood Revitalization Strategy Area (NRSA), are a one-time incentive of CDBG funds which are forgivable after one year of operating.



West Market Street Corridor Improvement Progress

This beautification infrastructure pilot project from 38th to Amy Ave and 39th Street is nearly complete. New trees, TARC benches and shelters, trash receptacles and planters should be installed by the end of September. The next section of the corridor scheduled for improvements is Louis Coleman/ 34th to 38th Street. Further infrastructure improvements will be scheduled pending funding availability.



Put a bag in your car to dispose of trash later. Adopt a block or corner and pick up the trash in your neighborhood!

You may call 574-1000 or 311 to report a litterer. Provide the license plate number of the person littering to the MetroCall Operator. That reported person then receives a letter in the mail informing them that they were seen littering.



LMPD CRIME PREVENTION TIPS

1. **Keep lawn equipment and other valuables in a secure area. Mark valuables so that if something is stolen, it can be identified when found. A lot of items are recovered at pawn shops.**
2. **Inspect doors, garages and windows to make sure they are secured properly and with good locks. Garage doors should be closed when not in use and secured overnight.**
3. **Remove valuables from vehicles overnight even when they are parked in the driveway.**
4. **Are homes in need of additional exterior lighting? Check all lights to make sure they work. All globes should be clean and unbroken. Driveways, front yards, garage doors and residence numbers should be lit. Motion sensor lights can be used in the front and back of the home. Street lights should be spaced properly and not have anything blocking them. Timers may be used with interior lamps.**
5. **Leave a radio or television plugged into a timer when away from the house to confuse a possible intruder with the noise.**

The app allows you to submit service requests, including reporting potholes, a stray animal, a burnt out street light, drainage issue, garbage and recycling information and much more! You can also take a picture and submit the problem! Check it out on the iPhone App Store, Google Play and the Windows Phone Store.

Did You Know?... It's the law! Be a good neighbor!

Property Maintenance is an important concern in District 5 for maintaining and improving our quality of life.

Enforcement of codes ensures the safety and comfort of all residents and goes a long way toward maintaining property values and keeping the neighborhood safe. Here are some of the most common codes/laws that Codes and Regulations/IPL enforces metro wide:

Property Maintenance

- Homes should be kept in good repair with all wood surfaces covered or painted. (IPL or Ord #156.053 A&B)
- No cooking grills on front porches, front yards or side walks (IPL)
- No interior furniture on front porches. Only patio furniture is allowed on porches or yards. (IPL)
- No basketball goals on the street (IPL)
- Do not put trash containers out until the day before trash pick-up and put container back in your yard after trash pick-up. (IPL)
- You are responsible for removing graffiti from your garage, house or fence (Ord. # 156.052)
- Gutters and downspouts should be properly connected (Ord #156.053 G)
- All homes should be secure with no broken windows or doors. (Ord 156.053 N)
- Grass may not exceed 10 inches in height. (Ord 156.052 D)
- No rubbish, trash, yard trimmings, etc. allowed on property front or rear (Ord #156.055 A)
- Brick, vinyl, and other exterior sheathing must be maintained with no cracks, holes or rot to prevent entry by pests. (Ord #156.053 D)
- Any exterior stairs with three or more treads must have an approved handrail. (Ord 156.053 M)
- All dogs should be fenced in the backyard only, licensed and tagged. (Animal Control)
- Dogs must be on a leash when walking or jogging. (Ord # 91.002)
- House numbers should be posted and visible in the alley on your garage or fence

Vehicles

- Vehicles with 3 or more unpaid parking tickets can be immobilized with a "boot" and towed even if the car is parked illegally

- Vehicles used for illegal dumping may be impounded for a period not more than 12 months. It will not be released until there is proof that all fines, clean up costs and tow lot fees have been paid.
- Vehicles on private property must be parked on a hard durable surface; gravel drives must be approved. (IPL 156.052 H)
- All motor vehicles parked outside must be licensed and operable. No flat tires, missing wheels or broken windows (Ord # 72.039 c Private call IPL)
- No parking on grass, blocking sidewalks or on vacant lots. (Grass call IPL; Sidewalk: Ord 72.035 c)
- No auto shops or car repair set up as businesses, in a residential area (IPL)
- No tractor trailer trucks on any of the streets and especially not overnight. (Ord 72.033)
- Do not park your vehicle on the street during posted hours for street cleaning. Vehicles will be subject to ticketing and towing.


If you receive a violation notice: you may contact the inspector whose number will be on your letter. Minor violations will be given 10 days to remedy. If you receive a major repair violation, the IPL inspector will be more than likely willing to work out an inspection schedule that provides you reasonable time to get your violation corrected.

Reporting Violations: If you see a vehicle or property maintenance violation you may report them—anonously to MetroCALL by calling 311 and give detailed information 24 hours 7 days a week. Be sure to get a tracking number from your complaint when you report a violation so we can help follow up on your complaint.
