As a community, we applaud our neighbor, retired judge, Dr. Andrew J. Hairston for the honor of the renaming of Newport Street to Andrew J. Hairston Place. The ordinance for the renaming was presented to the Atlanta City Council by Councilman Ivory L. Young, Jr. The council voted unanimously for the renaming and it was effective April 30, 2014.

The application for the street rename was submitted by Judge Hairston's church, the Simpson Street Church of Christ, where he has preached and led the congregation for 53 years. He is not only a longtime minister, but a civil rights leader, a lawyer, former Atlanta City Solicitor and City Court of Atlanta Chief Judge.

The renaming celebration was held on September 11, 2014 near the Simpson Street Church of Christ at 12 noon at the corner was Joseph E. Boone Blvd and Newport Street (now Andrew J. Hairston Place). I was so honored to be able to attend and witness the awesome tributes to Dr. Hairston as we heard from so many individuals who shared their personal stories attesting to his commitment to God, his family, his church and community, as well as his integrity and outstanding character. It was easy to see how the devoted the celebration attendees were we sat outside in extreme heat to testify to our support of this honor to Dr. Hairston. I believe I speak for the entire community in saying "Dr. Andrew J. Hairston, we honor you!"
