AMENDMENT TO CEDAR CREEK LANDING DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

WHEREAS, the original Cedar Creek Landing Declaration of Covenants,

Conditions and Restrictions were declared by Thetavest, Inc., and were recorded in the

Office of the Recorder of Deeds, in and for Sussex County, in Deed Book 2101 at page

170 on January 19, 1996.

NOW THEREFORE, Cedar Creek Land Owners Association (hereinafter "Declarant") hereby amends and corrects said Cedar Creek Landing Declaration of Covenants, Conditions and Restrictions as follows;

- 1. Revise Article IIX, Section 1, Second Line (2) the portion thereof;
 - (2) Subject, however to the provision that the Association or it's successors, by and with the vote or written consent of eighty percent (80%) of the eligible votes of the membership, shall have the power to waive, abandon, terminate, modify, alter, change, amend, eliminate or add to these Restrictions and this Declaration at any time hereafter.

And substitute in lieu thereof the following;

Subject, however to the provision that the Association or it's successors, by and with the vote or written consent of at least fifty-one percent (51%) of the total membership at any regular or special meeting, provided that notice of the proposed amendment shall have been given to each Owner at least ten (10) days in advance of such meeting or pursuant to written instrument duly executed by a majority of the Owners, shall have the power to waive,

abandon, terminate, modify, alter, change, amend, eliminate or add to these Restrictions and this Declaration at any time hereafter.

 Except as hereby amended, the Cedar Creek Landing Declaration of Covenants, Conditions and Restrictions, recorded in the office of the Recorder of Deeds, in and for the Sussex County, in Deed Book 2101 at page 170, is hereby ratified and confirmed.
