CD-11 Report. Norman Kulla reported that he, Marilyn, Doug and George met with representatives from the City of Santa Monica this afternoon for an update on the California Incline. The bad news is that the CIRS project completion has been delayed further; probably to mid-July because of continuing issues with the soil under the coast highway.

BOCA report. Doug reported on the to be installed No Left Turn signage at OAE and Mabery.

Park Report. Tracie reported that there have been parking problems with local construction workers parking their vehicles at the park. LADOT parking has been citing them. There are lots of new classes being offered this summer and she urged everyone to take a look. Vesh reminded us that Rustic Nights will be held the first Saturday in June, June 6. It will be a bigger event than last year and that all funds raised will go to Rustic Canyon Park. An historical architect, Taylor Louden, has been hired to consult on the Clubhouse restoration.

Committee Reports:

- Traffic. The California Incline project will start this next Monday, April 20. Doug
 has prepared a comprehensive FAQ/fact sheet for distribution to residents. The
 No Left Turn from Ocean Ave. Extension to Mabery will be installed by the end
 of this week. Marilyn reported on the City construction of the sidewalk on
 Entrada which will commence at the Amalfi stairs and continue up the East side
 of Entrada to Adelaide.
- **Homelessness.** Sharon. Officer Moore will be posting notices on the Bluffs, April 16, stating that it is illegal to be there, and the Bluffs cleanup is scheduled to take place April 20.

School report. Julie reported that the annual Canyon Fiesta was very successful. **PPCC Report.** No report.

Georges Report. The PCH Task Force has not met since February. A meeting is scheduled for April 23 at 5:30 to discuss the proposed extension of the beach pedestrian walkway from California Ave. to the Temescal Beach parking lot. The objective is to increase safety by having separate paths for bicyclists and pedestrians. A state grant is being sought.
