DUMPSTERS, DONUTS & DONATIONS

Chalk up another successful Dumpster Day this year! The dumpsters were full and compliance was 100%,

which means that the city will most likely offer this invaluable service again next year.

Special thanks go out to Jose Rodriguez who offered to oversee a dumpster on Center St. to make it more convenient for residents on that side of the neighborhood.

LARGE ITEM PICK-UP

In tandem with the recent Dumpster Day, it's a good time to remind everyone that the city offers its residents free curbside collection of large bulky items twice a year. Each pick-up is limited to two (2) bulky items, which may include furniture, mattresses, water heaters, household appliances (stoves, refrigerators, etc.), rugs, etc. To arrange for a bulky item pick-up, either call Waste Management at 714-558-7761 at least one day ahead or schedule online at www.wm.com at least 2 days ahead. Note: Hazardous waste will not be collected and you will need to provide a description of items to be picked up.

E-REPORTING OF CRIME

The city has recently instituted an online method for reporting non-violent crimes such as vehicle break-ins, identity thefts, harassing phone calls, etc. Using this online citizen police report system allows you to submit a report immediately and print a copy of the police report for free. To use this service, log on to the City of Santa Ana's website (www.ci.santa-ana.ca.us), click on "Departments"; then, in the right-hand margin, click on "Police Department"; then click on the "E-Reporting" icon.

According to city officials, use of the online system is intended to increase response time to priority or urgent calls by not taking officers off the street for non-violent crimes.

GARAGE SALE WEEKEND

The next garage sale weekend is September 5 & 6. Signs are still being left up beyond the weekend. PLEASE take down your signs!

CODE ENFORCEMENT

Another sweep of the neighborhood will be conducted in the near future. With assistance from the Association and the Code Enforcement volunteer squad, the city is cracking down. Violators are being issued sizeable fines for infractions such as not removing holiday lights, leaving inoperable vehicles parked in driveways or on the street, parking commercial vehicles in the neighborhood, etc. This is your fair warning - do it now!

SUMMER RECIPE

Grillin' season is just around the corner, and here's a recipe sure to get your taste buds goin'!

Blue Moon Burgers



Prep time: 10 mins, Servings: 4

Ingredients:

- 1 lb ground beef (do not use lean -- gotta have some fat for a juicy burger)
- 4 large toasted burger buns (use a hearty bun that will stand up to juicy burgers)
- 4 oz. crumbled blue cheese
- 4 oz. softened cream cheese
- 4 slices Monterey Jack cheese

Toppings:

- mayonnaise
- thinly sliced red onion
- iceberg lettuce
- sliced tomatoes

Directions:

 Combine blue cheese and cream cheese; mix well; set aside to meld flavors.

- 2. Form the ground beef into 4 patties; season front and back with favorite seasonings; grill.
- 3. When the burgers are done, add 1/4 of the blue cheese/cream cheese mixture to the top of each burger.
- 4. Top with a slice of the Monterey Jack cheese.
- 5. Spread mayo on each side of toasted buns.
- 6. When the Monterey Jack cheese is somewhat gooey, place burgers on buns.
- 7. Add remaining toppings.
- 8. Enjoy!

(Cook's Note: Do not add ketchup - ketchup and blue cheese do NOT go together!)
