Kevin indicated that the order of the meeting will be changed so our guests from Pima County can explain the new changes and opportunities with the CDBG Program that they would like to present at our next general meeting. Gloria Soto distributed the CDBG Zona Grants TA – new online applications and deadlines for 2016-2017. There will be no more two year terms for Public Service CDBG. There are now required pre-applications that must be filed. The monthly reports are not online yet though. There was a discussion of the CDBG funded street light program in the Flowing Wells and Rillito area that we have been funded for. Gloria is going to get George a map of the funded lights in the Rillito area so he can check to see if they are working. TEP does not check to see if they are out so we or the area residents must do so. Gloria and John Metheny talked about the Emergency Solutions Grants from HUD to support Homeless in the community. The grant covers shelter and maintenance and street outreach with rapid housing help. There are motel vouches and rent assistance (do not housing). Up to 24 months of assistance, CDBG is only for one year, but sometimes you get can additional funding.

Secretary's Report: George presents the minutes from the September 3, 2015 Board Meeting. There were three correction noted. Sue made a motion to accept the minutes as written with three corrections. Susan seconds the motion, everyone agrees. George presents the minutes from the September 21, 2015 Board Meeting. There were no corrections noted.
