



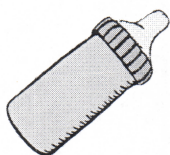

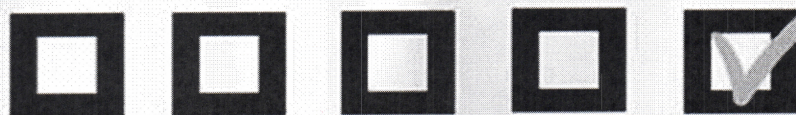

Screening, Brief Intervention, and Referral to Treatment (SBIRT) is an integrated, public health approach to the delivery of early intervention and treatment services for persons with substance use disorders and those at risk of developing these disorders. Overall, substance use contributes to over 70 conditions that require medical care. Screening can be easily used in primary care settings and enables healthcare professionals to systematically identify and assist people whose drinking or substance use may

Project Coordinator's Report
December 21, 2015**

- Met with Fiscal Agent, Shawnee Christian Healthcare Center, to determine reporting requirements for grant; discussed policy and procedures for expenses.
- Coordinated press conference and movie night on November 13, 2015. Emailed voting tool to coalition members for voting of officers. A total of 60 were in attendance (including children).
- Submitted Articles of Incorporation to Kentucky State Treasurer for a Non-profit Corporation. Awaiting determination.
- Met with Shawnee Arts & Cultural Center staff and program staff to introduce grant strategy and to discuss partnership opportunities and the engagement youth in strategy activities. Will engage youth who participate in current programming at Center to become a part of Shawnee Youth Advocates.

Had a subsequent meeting with Ben Johnson, Louisville Metro Parks & Recreation, to provide overview of grant and partnership opportunities with Shawnee Arts & Cultural Center.

- Met Dave Christopher, Executive Director of AMPED to discuss partnership opportunities in regards to the development of a social access prevention campaign. AMPED utilizes digital media (music and video) as youth development tool within the Chickasaw community and is housed at the Flaget Community Center. Discussion focused on the creation of a documentary to address youth substance use and abuse.

Additional funding opportunities are available to help offset cost of documentary development. Documentary will be created by youth and used in awareness campaign within schools, churches and throughout the community.

- Conducted interviews of 6 candidates for part-time office/program assistant. Selected Renata Milan for position.
- Attended DFC Conference December 6-8, 2015.
- Began purchasing items for office set up. Finalized MOU with the Fuller Center for Housing for office space.
- Submitted request to host a Towne Hall Meeting in 2016, As a DFC Grantee, we were invited by the Substance Abuse and Mental Health Services Administration (SAMHSA), to join in the *2016 Communities Talk: Town Hall Meetings to Prevent Underage Drinking* initiative. If awarded, STYC will receive \$500.00 to cover cost for event.

Met with Northwest Neighborhood Place and The Academy @ Shawnee to begin planning a community conversation/Towne Hall Meeting with a panel of youth speakers. Working with youth group to flush out topics for discussion.

I. Welcome/Introductions

Shawnee Transformation Youth Coalition (STYC)
Financial Accountability Policy
DRAFT

All expenses incurred on behalf of the Shawnee Transformation Youth Coalition (STYC) must be approved PRIOR to purchases. This process allows STYC to prepare for its cash flow needs and make adjustments as necessary for unbudgeted expenses. The purpose is to ensure that STYC fulfills its mission in the most effective and efficient manner and to remain accountable to stakeholders, including clients, partners, funders, employees, and the community. In order to accomplish this, STYC commits to providing accurate and complete financial data for internal and external use by the Fiscal Agent, Project Coordinator, and the Executive Committee of the Coalition and to facilitate reporting and obligations in connection with funding sources. If at any time a Project Coordinator is not appointed, all references to the Project Coordinator shall be deemed to be a reference to the Chair of the Coalition, unless otherwise noted.

Purpose of checking account

The checking account is used in the management of the Coalition's ongoing financial operations. The account may be held at any FDIC-insured financial institution selected by the Project Coordinator and approved by Coalition's Executive Committee. The Chair, Vice-Chair and Treasurer are the only members with the authority to open and close monetary accounts as needed to facilitate the coalition's needs.

Location of Coalition Checkbook

The checkbook will be physically located at the administrative office of STYC located at 4509 W. Market Street. It must be locked and secured when not in use.

Identity of Signators

Signators on the account are the Project Coordinator, Coalition Chair, Vice-Chair and Treasurer. Signature cards will be amended at the beginning of each calendar year, preferably during the month of January.

Number of signatures required

Two signatures are required on all checks. Whenever possible, the Chair/Treasurer will provide one or both of these two signatures.

Processing of checks

Checks may be processed when accompanied by a check request form or expense approval form and one of the following documents: a) a vendor invoice or purchase order, b) a written receipt to reimburse a Coalition member who has handled an expense on behalf of the Coalition, or c) a completed order form (for ordering of name badges, supplies, etc. on behalf of the Coalition). Payment will be made in 30 days or less with proper documentation.
