Manor Lake Community General Meeting

North Branch Hiker-Biker Trail Project Update

In our September 2017 newsletter, we mentioned there was a public meeting to discuss the plans for the trail and gain input from the public regarding the location of a parking lot for 15-20 cars at the trailhead near Muncaster Mill Road. The original location off Muncaster Mill Road, about 1000' west of Emory Lane (Option A), had received a number of objections from the Norbeck Manor Home Owners Association due to its proximity to homes and perceived security and safety concerns. A study of possible alternative locations was conducted and a location on Meadowside Lane near the Lanthrop E. Smith Center was identified as the most viable (Option B). ([see map](#)).

The public was invited to comment and vote on their preferences at a public meeting last September (attended by a ML board member) and at an open town hall on the project's website. Preferences from 89 people were submitted. Of those, 70 were in favor of Option B. (Option A had previously been approved by the M-NCPPC Planning Board.) In view of the significant support for Option B, Montgomery Parks presented the alternative location and other minor plan amendments to the Planning Board on November 30, 2017, for their approval.

The Planning Board has approved the amended plan including Option B. Interested parties can read a complete description of the project, including both the original and amended plans with many maps and photos, as well as all the public comments in the Montgomery Parks staff recommendation, on the Planning Board's website using this [link](#).

Considering the changes and time required to proceed through various approval and funding cycles of the state and county organizations, Montgomery Parks now anticipates that construction will begin in late spring of 2019. They plan to construct in phases/sections with an effort to maintain as much of the trail open as possible during construction. It appears that the major impact to Manor Lake would be from construction or worker vehicles entering the staging areas in the old parking lots along the Lakeside Trail via Bauer and Trailway Drives. However, Montgomery Parks is hoping the contractors can move their equipment into the existing parking areas at the beginning of construction and have them remain there until work is complete (about 18 months later). This would reduce the occurrence of heavy equipment on streets in Manor Lake to only those two periods. You Spoke – And We Listened

Some astute residents contacted the MLCA Board a few months ago with the observation that the traffic light at Norbeck and Baltimore Roads seemed to be out of sync, causing major traffic backups close by at the Avery Road intersection, and beyond. A call was made to 311 by the Board, and the County came out to review the issue. The lights were adjusted as requested and traffic flow has improved. Thank you to our Manor Lake residents for reaching out!

2018 MLCA Membership Drive is in Progress

NOW IS THE TIME to pay your MLCA dues; MLCA membership follows the calendar year (Jan. 1 – Dec. 31). Please **do not take for granted the services that MLCA provides; while perhaps not evident on a day-to-day basis, you would soon notice if these services ceased.**

Example #1: Every day, when driving in and out of Manor Lake, you pass **the brick/stone wall and garden areas** that welcome you and your guests. The appearance and maintenance of these public spaces are **paid for by MLCA dues**. Additionally, the government strips on either side of the entrances, alongside and opposite the bus stops, are maintained by MLCA. While these are technically Montgomery County property, many will remember the grass growing thigh-high along both entrances, and if left to the County, the gardens would likely be grassed over and allowed to grow as high as it frequently does on the berms along Norbeck Road.

Example #2: Have you noticed the **extender pole/reflectors** attached to fire hydrants in the neighborhood in winter? These poles play a vital role in helping rescue personnel find the hydrants in the event of a fire during periods of snow. Many residents remember the home on Manor Lake Drive that burned to the ground about eight years ago due to deep snow preventing fire & rescue personnel from finding the nearest fire hydrant. These poles were given to the household closest to each hydrant, **provided and paid for with MLCA dues**.

Manor Lake Bulk Item Pickup Scheduled



Manor Lake residents who are current on their Civic Association dues are eligible for a free bulk item pick-up **once** during the membership year. Two pick-ups are scheduled each year; households whose MLCA dues are paid may participate in **one** at no charge. There is a nominal charge of \$5 for households whose dues are paid to participate in the bulk pick-up a second time. Your household must have its dues paid-in-full to participate.

The next bulk item pick-up event for Manor Lake Civic Association members is scheduled for Saturday, April 14, 2018. Neighborhood Watch Volunteers Needed

The Neighborhood Watch program needs additional volunteers. During the past two years we have lost volunteers due to residents moving out, illness, or death. Please consider helping to keep our community secure by volunteering. Participation requires about an hour of your time, once a month.

Schedules are sent monthly. You may request specific dates, or to change your dates as necessary. Volunteers patrol in two-person teams and may patrol at their choice of time of day. About half of the volunteers are married-couple teams. Others are neighbors who have gotten together to form a team.

If you would like to be paired with someone, let us know. Many burglaries and break-ins occur during the day while people are at work, so it would be nice to have volunteers who are retirees, people who work from home, or persons with flexible work hours that would allow them to patrol during the daytime. But don't let that deter you from signing up.

Entrance Island Re-Landscaping – New Look and Lower Maintenance Costs

In the fall of 2017, work proceeded on the MLCA-approved landscaping proposal to simplify and de-clutter the plant overgrowth at the Rocking Spring entrance island by expanding the area of grass, lowering the height of the flower bed in front of the Manor Lake sign wall, improving appearance and symmetry, and reducing the monthly maintenance cost to MLCA. This work has been completed, and feedback from residents has been very favorable.

This spring, similar work will take place at the larger Bauer Drive site, per the approval of the community at the October 2017 general meeting. At this site, not as many of the existing plantings will be removed,

but the grass area will be expanded, particularly on the north side of the pine tree. If plantings at the Bauer Drive site are removed, they may be re-planted at the Rocking Spring entrance, to provide background to the lighting of the Dr. Milenky memorial. Note that these improvements will reduce our annual landscape maintenance costs, and are expected to pay for themselves over a period of several years.



The survival of the new grass and other new plantings will greatly depend upon being fully watered, at least twice a week during the several weeks that immediately follow the planting. This was coordinated at the Rocking Spring site by the generosity of the Manor Lake homeowners nearest to that site – thanks to Terry Dowdy and Deborah Shum for their donation of time and water, to ensure the survival of the plants in the first critical weeks! MLCA is hoping the homeowners nearest to the Bauer Drive site will be similarly generous with their water supply when this work is performed this spring.

State Sen. Roger Manno Scholarship Application for the 2018-2019 Academic Year

Each year, Senator Manno awards scholarships to eligible students with, and without, special needs. Special needs include pervasive developmental disorders (PDD), autism, learning disabilities, emotional or behavioral disabilities, mental health challenges, developmental delays, or other special needs. Applicants must be in the process of completing their final year of high school, or in any year of college or graduate school, and must be enrolled or applying to a school in Maryland. A few exceptions may be approved by the Maryland Higher Education Commission for "unique" majors. Additionally, applicants must be residents of Legislative District 19, which includes portions of Silver Spring, Rockville, and Gaithersburg. Applications must be postmarked by June 1, 2018. Pedestrian/bicycle Bridge over Norbeck Road – Request for SHA Feasibility Study

The Manor Lake Civic Association has contacted the State Highway Administration (SHA) to request a feasibility study for a future pedestrian/bicycle bridge crossing over Norbeck Road (Rt. 28) in the area between Bauer Drive and Baltimore Road. This is an intersection where frequent vehicular accidents are the norm, putting pedestrians and bicycles at risk.

The advantages of a such a bridge in this area include safe pedestrian and bicycle access between the north side neighborhoods and the Rock Creek Village Shopping Center, making it much safer travel for children who walk or ride their bikes to and from Wood Middle and Rockville High Schools, less car traffic between the two sides of Norbeck Road, more business for the shopping center, and a better quality of life for all residents, as they can more safely walk to schools, shopping, and restaurants. This area could work with such a bridge, if it were built at an angle, thereby taking advantage of the high embankment adjacent to the shopping center, as well as the Norbeck Road service road median on the north side.

An SHA study was conducted in 2016 for this area, following SHA's attendance at the Manor Lake General Meeting held March 1, 2016. Their analysis and response pertained mainly to many traffic flow concerns, to address questions that focused on those topics. The subject of pedestrian safety, and certainly the question of a pedestrian bridge crossing near the Bauer Drive intersection, are new topics/questions that MLCA is bringing to SHA, since the March 1 meeting. SHA has indicated they will follow up on this, and move this new request through the right people and processes at SHA, and engage stakeholders. Let's see where this goes!

New Manor Lake Website

The MLCA board has been investigating new features that would enhance our community website. The current website utilizes a service that is inexpensive, but also limits the features that can be provided. Some of the websites found with desired features are designed for communities with true Home Owner Associations, where membership is mandatory and much more expensive than MLCA dues. Therefore, the features are built to support those communities. Features discussed include a listserve where residents can discuss home improvement vendors, resident and home services, and more specific and sophisticated advertising services.

Residents with knowledge, experience, and expertise in creating and maintaining websites are asked to contact a member of the MLCA board with information. Recent and Upcoming Maintenance on Solar Light System at Rocking Spring Entrance to Manor Lake

The professional-grade photovoltaic-battery, light systems at the Bauer Drive and Rocking Spring Drive entrances may appear to be maintenance free, but there are several tasks that need to be performed on a regular basis, to keep these systems operating at their best.

The solar panels at each site charge two, marine, deep-cycle batteries, also at each site, which provide the electric current to run the lights at night. Each system is designed/sized to run these lights for 3 to 4 nights, even after that many successive days of heavy cloud cover. Please note that these systems are "off the grid," so on those occasions when our neighborhood loses power for any extended time, these lights keep working! Recent and upcoming maintenance tasks are described below.

- In December 2017, the batteries at the Rocking Spring entrance were replaced, following approval of the expense by the MLCA board. The original batteries had been in service since September 2011, when the systems were first installed. These batteries had been due for replacement for many months, as indicated by more frequent outages that residents may have noticed. This is the largest maintenance expense, as each of these deep cycle batteries (different than a typical car battery) costs about \$375, and lasts between 5 to 6 years.
- The LED light fixtures at the Rocking Spring site are also original equipment, and the individual LED nodes have developed a burned or browned type of damage, resulting in a dim output from these fixtures. In 2018, these fixtures will be replaced with newer model fixtures which will have replaceable LED bulbs; an alternative under consideration is to install LED rope lighting behind the Manor Lake raised letters on the Rocking Spring wall to provide a new attractive backlit appearance. Both options will be evaluated for cost effectiveness and desired effect, and presented to the MLCA board for a decision.

This report was prepared by Bret Lyhus, Manor Lake resident and current member of the MLCA board of directors. Bret has worked in the energy industry for 30 years, including in the areas of power generation, distribution, and energy efficiency consulting. Bret managed the project to install solar lighting at the two Manor Lake entrances, and maintains the systems at both sites.

Who are the Manor Lake Civic Association Board of Directors?

Manor Lake Civic Association Dues – at Work for You!

Were you like me when you first drove into the neighborhood to look at a house for sale – impressed that the neighborhood had a name, let alone an entrance sign announcing it? And a well-maintained garden welcoming you?

As a resident of Manor Lake, I quickly learned what all must know – that we live in one of the most vibrant and desirable neighborhoods in Montgomery County. However, you may not know exactly what your Civic Association does on your behalf and how much it enhances the experience of living in Manor Lake and in Montgomery County.

Civic Association member dues – which are a bargain at just \$40 per year – goes toward, among other things:

 - Periodic Meet 'n Greet for residents with County Council Members and other local regulators;
 - Thanksgiving Turkey Trot;
 - Volunteer appreciation night
- Advocacy efforts which benefit the community, e.g., MCPS 400+ bus depot proposed for Avery Rd., improvements in traffic light timing, speed control, stop-signs, other traffic safety issues, highway/environmental noise, etc.;
- Neighborhood watch supplies;
- Bulk item pick-up costs;
- Neighborhood directory;
- More

Thanks to the residents who have already paid their 2018 dues. But we **need all of you** to be able to maintain our community at the high standard we've all come to expect and desire. Believe it or not, household membership hasn't been more than 52% in the past 10 years. That's why every newsletter uses valuable space explaining to residents what should be obvious – that paying MLCA dues does matter and are monies well-spent.
