#### Eagle's View HOA Annual Election Meeting

The EV HOA Annual Election was held on July 28, 2018. Kathy Clough (President) & Premier Property Management of DE representative Remington Rice & a few residents attended the meeting.

PPM spoke about the services they will be providing for the HOA. Some of those services will include collection of HOA assessments (beginning Jan 2019), bookkeeping, obtaining bids for community services & any other help needed by the Board.

The HOA Board of Directors will continue to vote on any new business, Architectural Review Forms, inspect homes in the community for Deed Restriction violations

& schedule any needed maintenance for the Community.

Some business brought up by resident(s) at the meeting included:

-Community Maintenance issues that need to be addressed. The significant overgrowth of brush & limbs over the speed limit & children at play signs (at the Greens Branch Ln entrance). They need trimmed back. Kathy indicates she will have our landscaper do so. They will also move the two EV Common Area signs ((that indicate no swimming, fishing etc)) to be more visible in our large retention pond area. \*These two items have been addressed & completed by EV lawn care provider.\*

-The Pet Waste Station that is missing (on GBL Common Area) will also be replaced & brush cut from the existing sign that remainsthat sign is completely engulfed in brush as well.

-PPM will see if it was possible to consider an EV entrance sign on GBL-since DelDOT vetoed any signs at the Summer Drive entrance due to right of way issues. The property management company is checking on that now.

-Resident at 502 GBL has volunteered to do a newsletter & revamp the Community Bulletin Boards.

The EV Declaration of Restrictions were created by the developer & builder prior to the Community being built. Attorneys from both sides create & agree on these restrictions. Home owners agree to & sign the Declaration of Restrictions (or more commonly known as 'Deed Restrictions') at settlement. The importance of the Deed Restrictions are to keep the Community & resident's property in good repair, safe, sanitary & aesthetically pleasing. The purchase of a home is the biggest investment we make. It is important to maintain our property in high regard for higher property values.
