Policy 306 - DRAFT Complaint Intake and Classification Process, is now OPEN for public comment. Here's what you need to know:

Required actions for BPD officers regarding public complaints:

Current Policy:

There is no policy currently on the books about how to assist citizens that would like to make a complaint against a police officer.

Draft Policy:

1. All complaints received about BPD member misconduct shall be accepted.
2. During all interactions with a person wishing to make a complaint, member shall ensure their body-worn camera is activated for the duration of the exchange. See [Policy 824, Body-Worn Camera](#).
3. All BPD sworn members shall carry **Unified Complaint Forms** in their BPD vehicles, and shall provide forms to persons upon request.
4. All BPD sworn members shall provide their name and badge number in writing upon request to any person.

5. Upon submitting the Unified Complaint Form, the complainant will receive a copy of their completed form and a CC# as a reference number when inquiring about the status of their complaint.
